What is this Fund?

Type	The Fund is a sub-fund of HANetf ICAV (the ICAV), an open-ended Irish collective asset-management vehicle umbrella fund with segregated liability between sub-funds, with variable capital established under the laws of Ireland and authorised by the Central Bank under the UCITS Regulation 2011, as amended. The Fund aims to achieve capital growth over the medium to long term.

The Fund is actively managed and in order to achieve its investment objective the Fund will invest, in a manner consistent with the UCITS Regulations and Central Bank requirements, in a portfolio of global smaller companies. Specifically, the Fund will invest primarily in companies which, at the time of purchase, is (i) a constituent of the Benchmark (as defined below); or (ii) have a market capitalisation of between US\$250 million and US\$10 billion (Smaller Companies).

The Fund will invest in Smaller Companies primarily through investments in equities and equity related securities. While these will typically be common stock, the Fund may also invest in preferred stock, warrants and rights listed or traded on the Regulated Markets referred to in Appendix 1 of the Prospectus. The Fund may also acquire exposure to interests in Smaller Companies by purchasing depositary receipts such as GDRs and ADRs.

Objectives and Policies	<p>The Investment Manager may invest in companies domiciled throughout the world, including companies domiciled in or traded on emerging markets.</p> <p>When selecting Smaller Companies to invest in, the Investment Manager undertakes a bottom-up analysis of individual issuers. In its analysis of individual issuers, the Investment Manager utilises a combination of quantitative techniques and qualitative techniques.</p> <p>The Investment Manager may utilise a combination of any of the following to achieve the promotion by the Fund of the environmental and social characteristics outlined above or as indicators to measure attainment of the promoted characteristics:</p> <ul style="list-style-type: none"> i) Primary research; ii) Company engagement; iii) Third party ESG risk data (including climate analysis and principal adverse impact data); iv) Proxy voting research; v) Direct and collaborative engagement with companies and other investors / industry bodies; vi) Commitment to responsible investment codes; and vii) Alignment with UNGC Principles.

What are the risks and what could I get in return?

Summary Risk Indicator



The risk indicator assumes you keep the Fund for 5 years.
The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this Fund compared to other funds. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the Fund's capacity to pay you.

Be aware of currency risk. The Fund invests in securities denominated in currencies other than its base currency. Changes in the exchange rates may adversely affect the performance of the Fund. This risk is not considered in the indicator shown above.

The Fund does not include any protection from future market performance so you could lose some or all of your investment. Investment by the Fund in other collective investment schemes, emerging markets and use of derivatives may involve additional risks. Performance Scenarios

What you will get from this Fund depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The figures shown include all the costs of the Fund itself but may not include all the costs that you pay to your advisor or distributor/and includes the costs of your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back. Due to market risk exposure, you can lose some or all of the amount invested during the recommended holding period of 5 years.

- **The stress scenario** shows what you might get back in extreme market circumstances.
- **Unfavourable scenario:** This type of scenario occurred for an investment between 09/2017 and 09/2022.
- **Moderate scenario:** This type of scenario occurred for an investment between 07/2019 and 07/2024.
- **Favourable Scenario:** This type of scenario occurred for an investment between 03/2020 and 03/2025.

What happens if HANetf Management Limited is unable to pay out?

HANetf Management Limited, as PRIIPS manufacturer of the Fund, is not obliged to make any payment in relation to the Fund, such obligations being those of the Fund itself. The assets of the Fund are kept separately from those of the Manager. An insolvency or default of the Manager should not result in the Fund suffering any financial loss in relation to its assets. The amount the Fund is obliged to pay out is linked to the net assets of the Fund so it is unlikely that the Fund will be unable to pay out unless there is an operational error or an insolvency or default by the Depositary which holds the Fund's assets on its behalf. In the event of the insolvency or default of the Depositary, securities held by the Depositary on behalf of the Fund should be protected but the Fund may suffer loss in relation to cash and certain other assets which are not protected. Investment in the Fund is not covered by any investor protection scheme.

What are the Costs?

The party advising on or selling you the Fund may charge you other costs. If so, this party will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover one-off, ongoing and incidental costs. These amounts depend on how much you invest, how long you hold the Fund and how well the Fund performs. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return).
- For the other holding periods we have assumed the Fund performs as shown in the moderate scenario.

How long should I hold the Fund and can I take my money out early?

The Fund has no required minimum holding period but is designed for longer-term investment, though it is recommended that you stay invested for at least 5 years. Investors are able to sell their investment on any day on which banks are open in the UK. When you cash in or if you switch between sub-funds, there may be a delay of up to 5 days for this Fund. By selling the Fund earlier than the recommended holding period, you may receive back more or less than you would have received if you had stayed invested until the recommended holding period. A redemption or exchange fee of up to 3% may be payable to the Manager by authorised participants in such circumstances. Other Investors, i.e. those who sell shares typically on exchange, may be charged additional fees by their broker. You can make regular and one-off withdrawals. Withdrawals could be greater than any growth achieved and could reduce your investment's value below the amount invested. You should refer to the Prospectus and Supplement for the Fund for the conditions that apply and information on tax.
