## Description of the Index

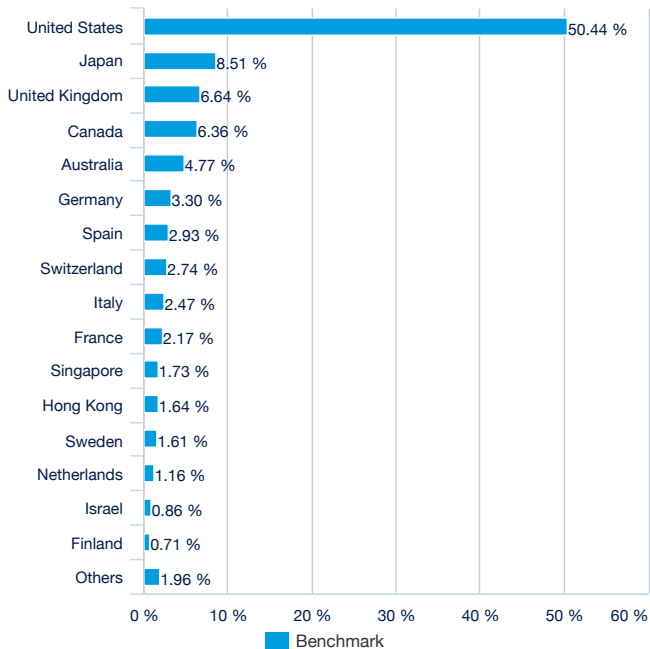

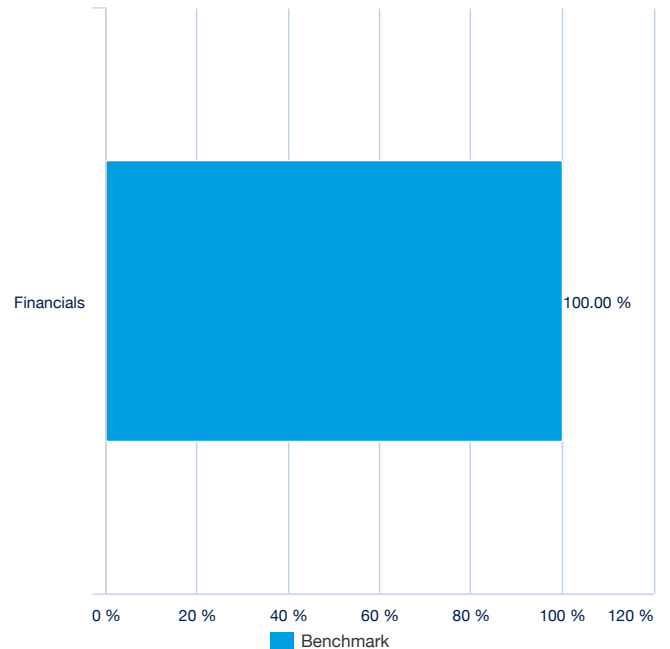
