
# **First Trust Cloud Computing UCITS ETF**



- The ISE CTA Cloud Computing Exclusions Index™ is a comprehensive, rules based index designed to measure the performance of companies engaged in business activities in the cloud computing industry. These companies offer internet and technology products, services and applications delivered via the internet, as opposed to traditional computing which focuses on computer desktop applications.
- The Index employs a modified theme weighted methodology which weights each company by a "Cloud Score". The total securities in the Index is 80.
- To be included in the Index, a security must meet strict Security Eligibility Criteria,: i. Minimum market capitalization of \$500 million; ii. Minimum free float of 20%; iii. Minimum three-month average daily dollar trading volume of \$5 million.
- A security must also meet certain ESG criteria
- All securities are classified according to the following three business categories: i. Infrastructure- as-a-Service (laaS): Companies that on-demand service; ii. Platform-as-a-Service (PaaS): Companies that deliver a platform for the creation of software in the form of virtualization, middleware, and/or operating systems, which is then delivered over the Internet; iii. Software- as-a-Service (SaaS): Companies that deliver software applications over the Internet enabling other companies to conduct their operations using the application.
- The Index then employs Cloud Score Weighting: i. At every Index evaluation, each security has its Cloud Score calculated by receiving a score for each category (laaS, PaaS, and SaaS), 1 if it is operating in that category and 0 if it is not. The maximum score that can be achieved is a 6 (3 for laaS, 2 for PaaSs, 1 for SaaSs); ii. Each company's total score is divided by the total sum of the scores in the universe to determine the weight of each security; iii. Individual security weights are capped at 4.5%.
- The Index is reconstituted and rebalanced quarterly.
