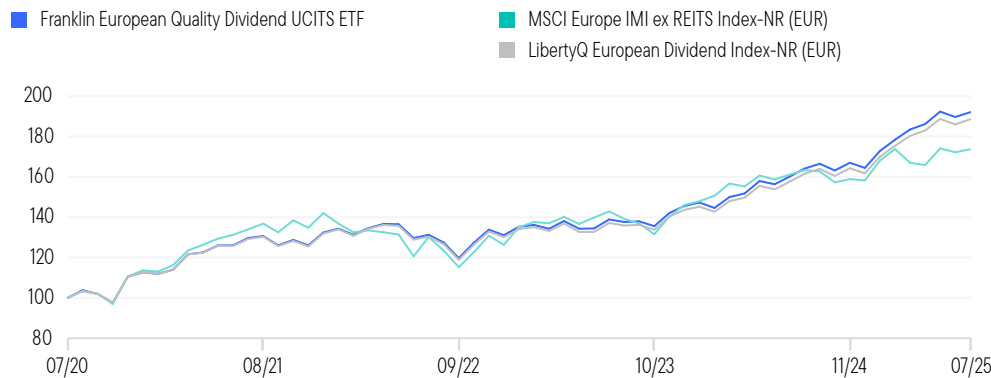

Glossary
