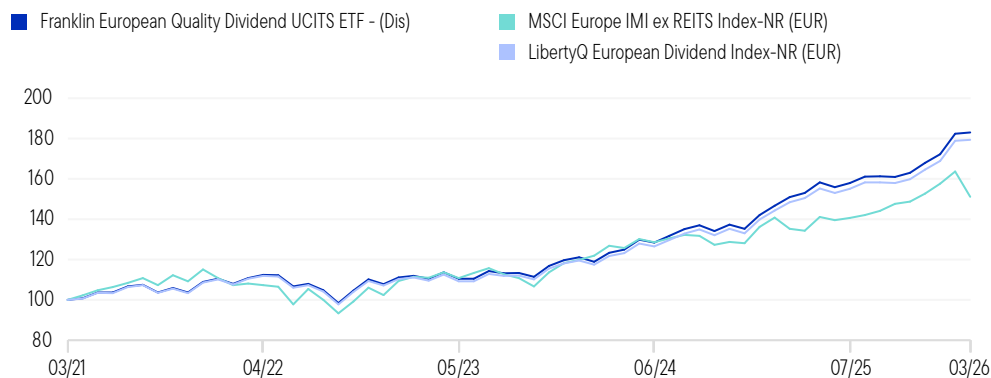

Glossary
