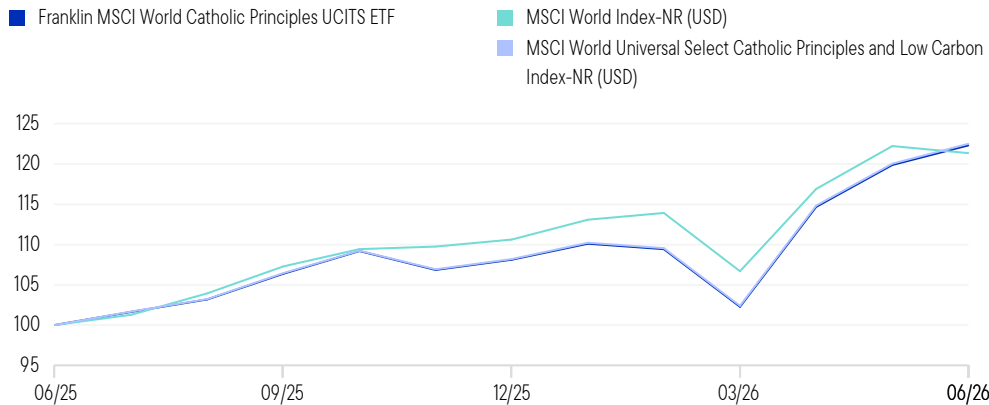

Glossary
