High Growth Potential

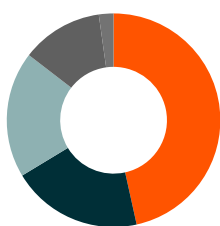

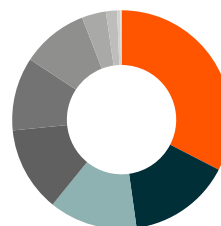
