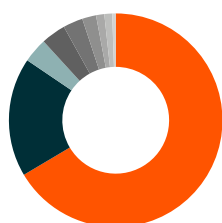

DEFINITIONS

Cboe Nasdaq-100 BuyWrite v2 Index The Cboe Nasdaq-100 BuyWrite V2 UCITS Index measures the total rate of return of a Nasdaq-100 covered call strategy. This strategy consists of holding a portfolio indexed to the Nasdaq-100 and selling a succession of one-month at-the-money Nasdaq-100 (NDX) call options.

¹Ongoing Charges is a measure of the total costs associated with managing and operating an investment fund.
