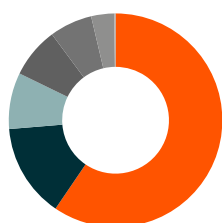

Mirae Asset European Infrastructure Development Index

The Mirae Asset European Infrastructure Development Index is designed to measure the performance of companies involved in construction and development of large-scale economic, social, and digital infrastructure projects across Europe. This includes companies involved in the engineering and construction of infrastructure projects including Data Center, and the production and sale of infrastructure raw materials, composites, and products. The companies that are involved in the sale and rental of heavy construction equipment and related products; the operation and maintenance of transport networks; and the production and sale of energy infrastructure products.
