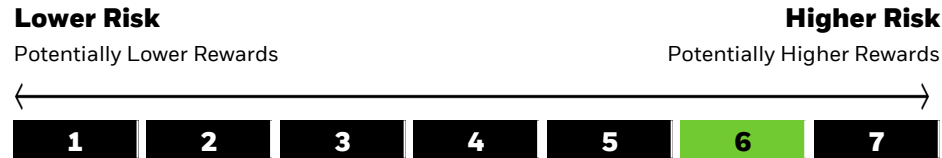

FUND OVERVIEW

The Fund seeks to provide investors with a return, made up of capital growth and income, which reflects the return of the MSCI World Value ESG Reduced Carbon Target Select Index.

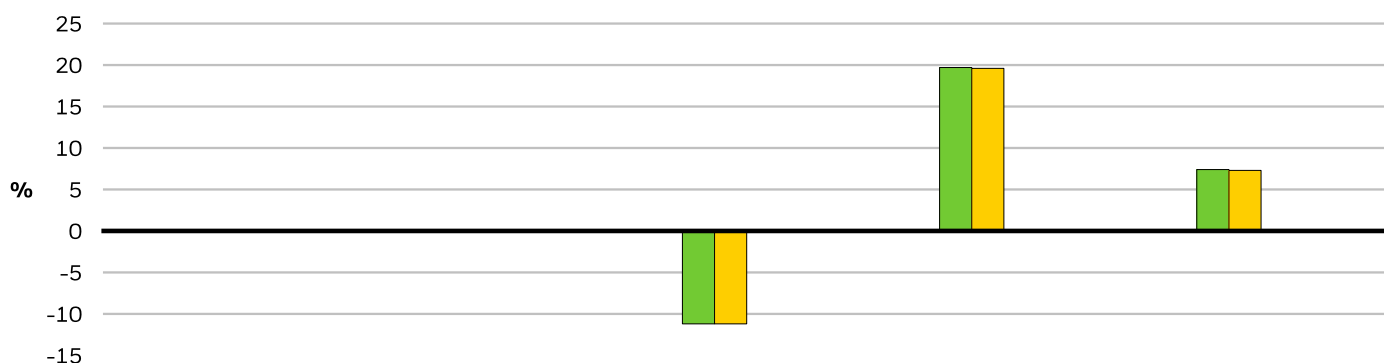

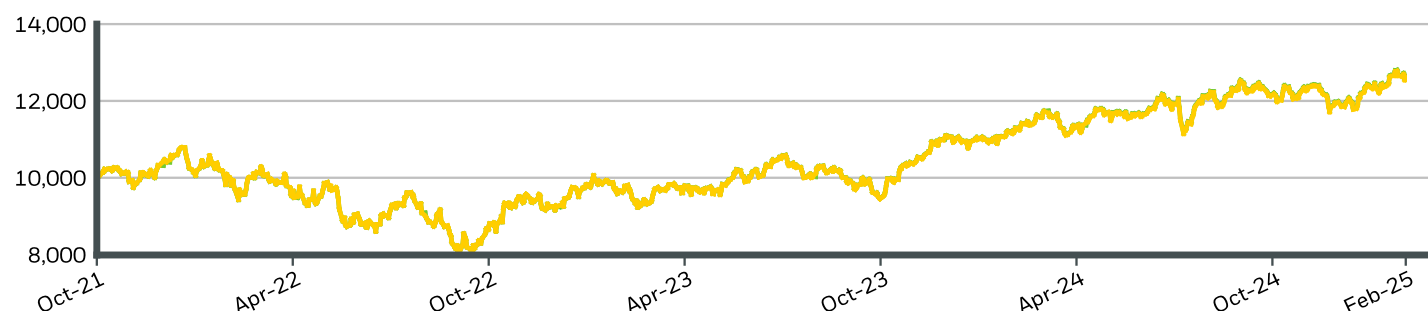

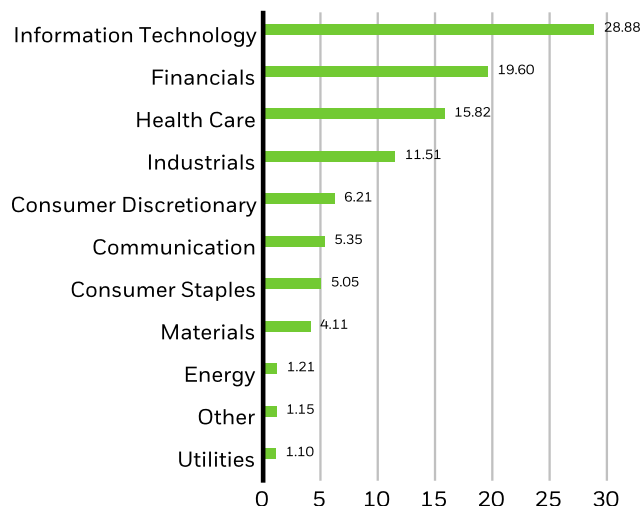

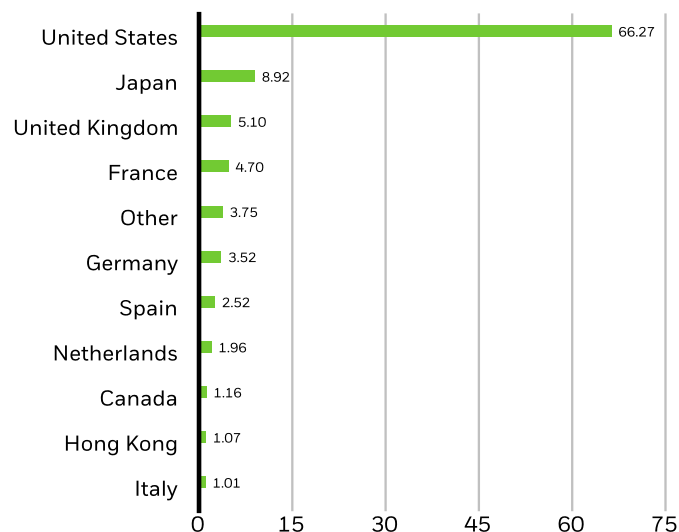
SECTOR BREAKDOWN (%)
