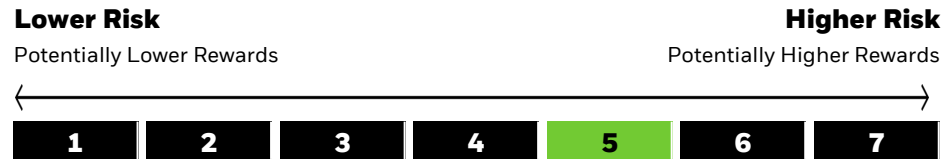
FUND OVERVIEW

The fund aims to achieve a total return, through a combination of capital growth and income on the Fund's assets, which reflects the return of the STOXX Europe Targeted Defence Index, the Fund's benchmark index ("Index").

KEY BENEFITS

- 1. The Index is a free-float adjusted market capitalisation weighted index that comprises European equity securities of companies included in the STOXX Europe AC All Cap Index (the "Parent Index") which receive revenue from business activities relating to military equipment and services.
- 2. The fund seeks to exclude companies classified as non-compliant with the United Nations Global Compact (UNGC) Principles and excludes issuers deemed by the index provider to be involved in controversial weapons.
- 3. The Index selects companies from the Parent Index that derive a minimum percentage of revenue from "Military Equipment and Services," assigns them to High, Medium, or Low Revenue Tiers based on this revenue, and allocates a minimum proportion to each tier while weighting the Index (the STOXX Europe Targeted Defence Index) to favor companies in the High and Medium Revenue Tiers according to the index methodology.

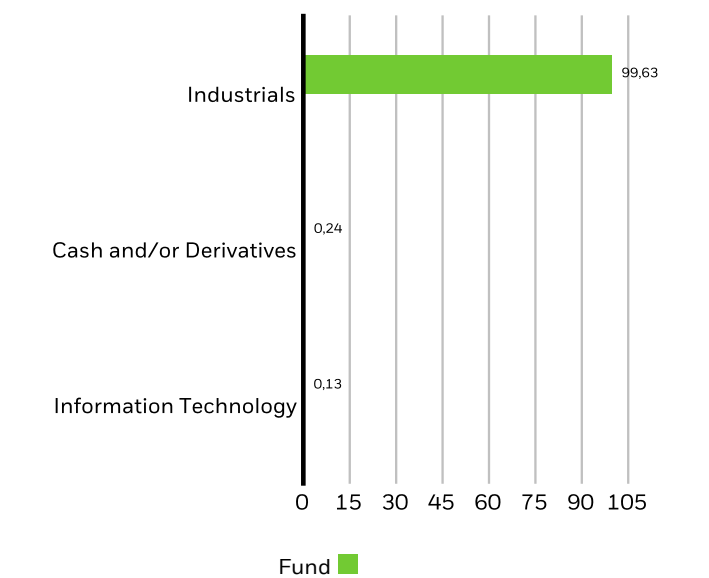

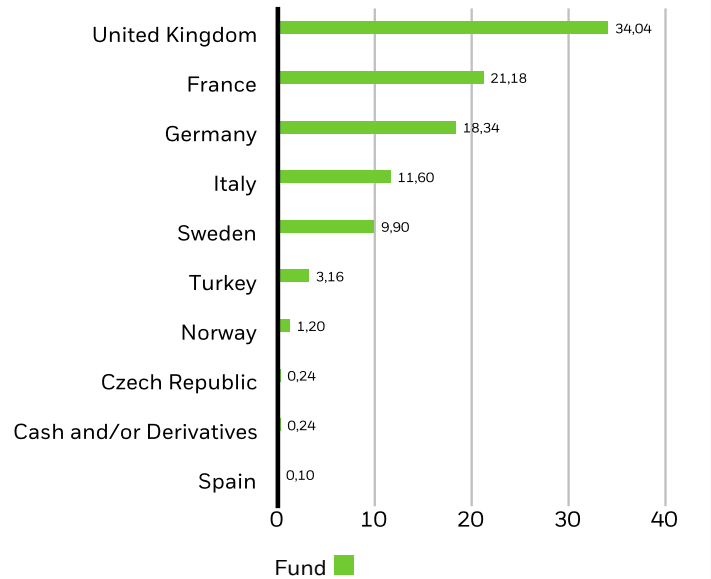
