3. Single country exposure and JPY exposure hedged back to GBP monthly

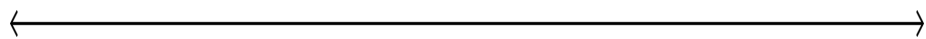

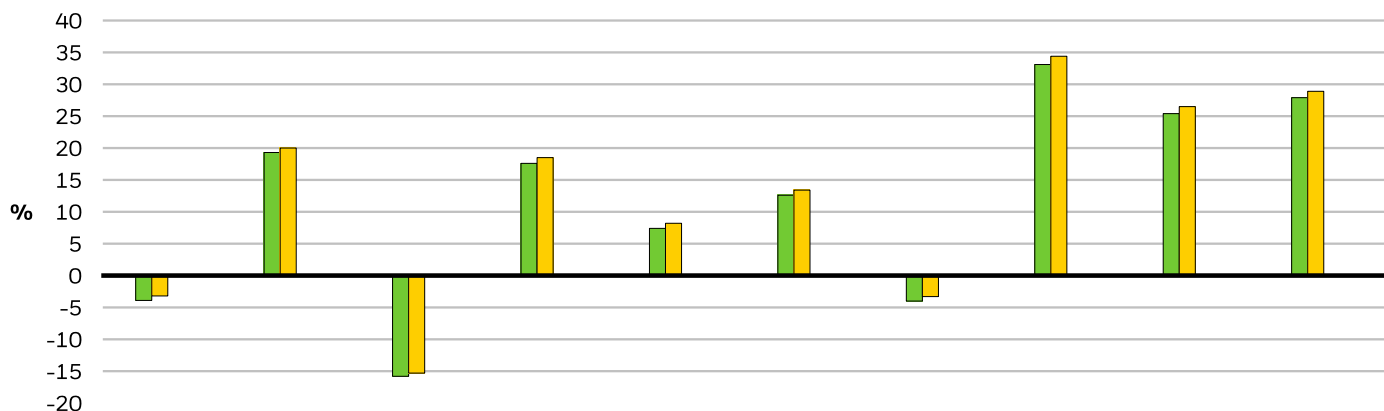

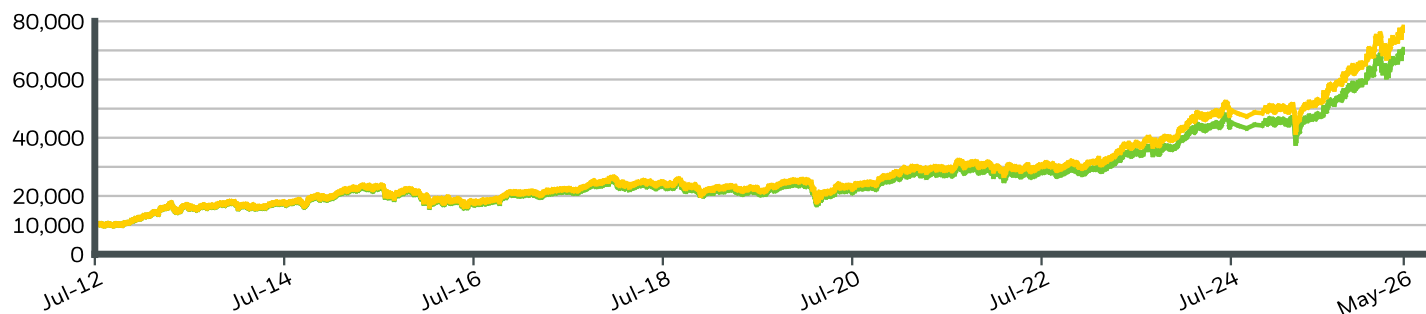

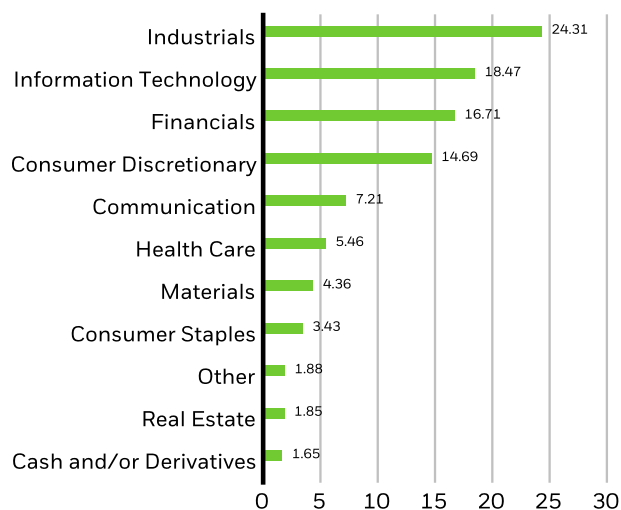
