FUND OVERVIEW

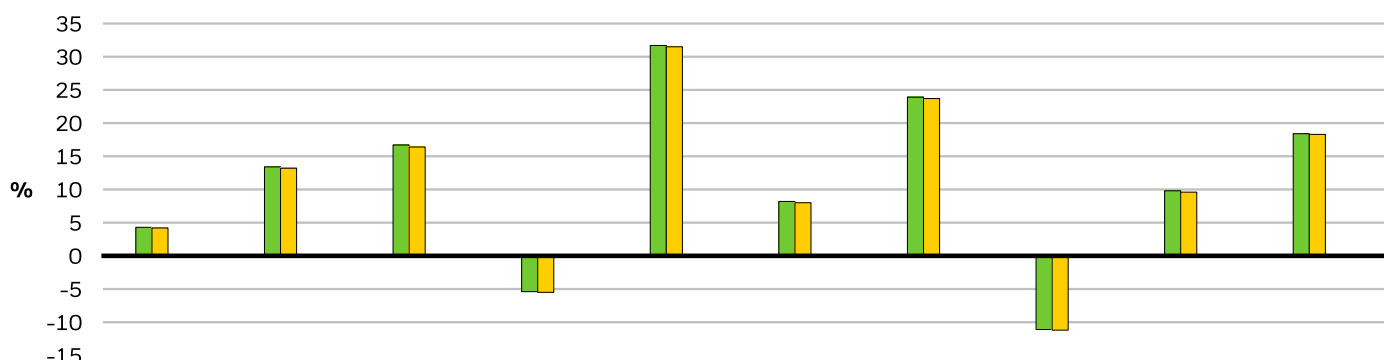

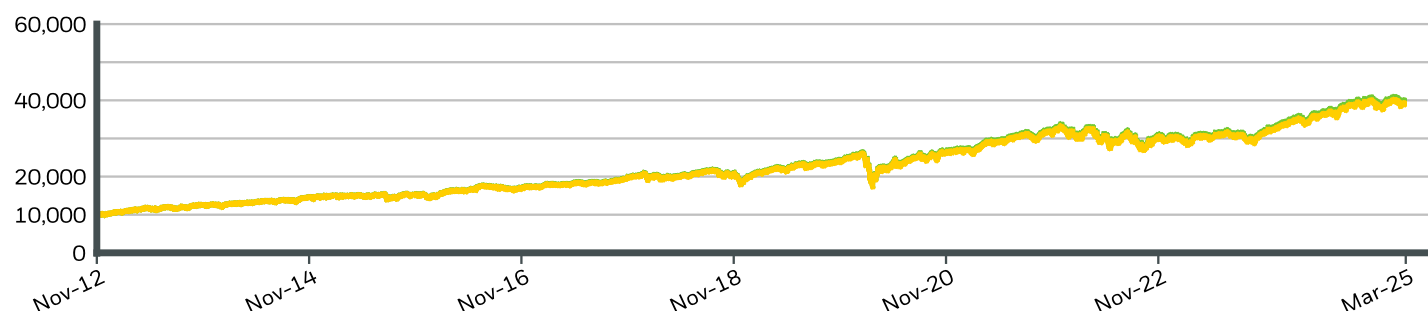

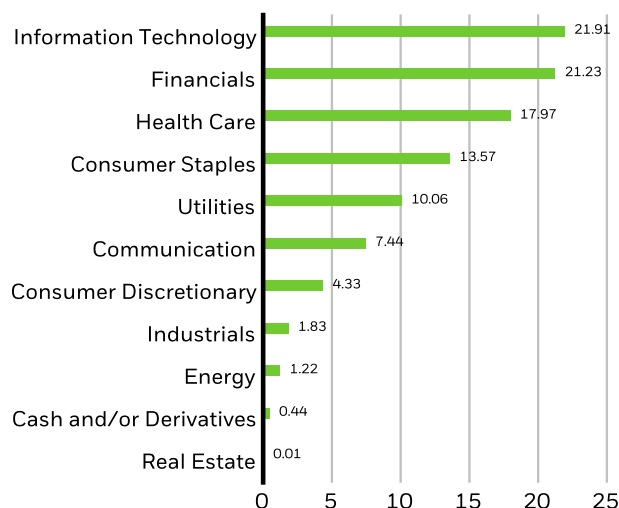
