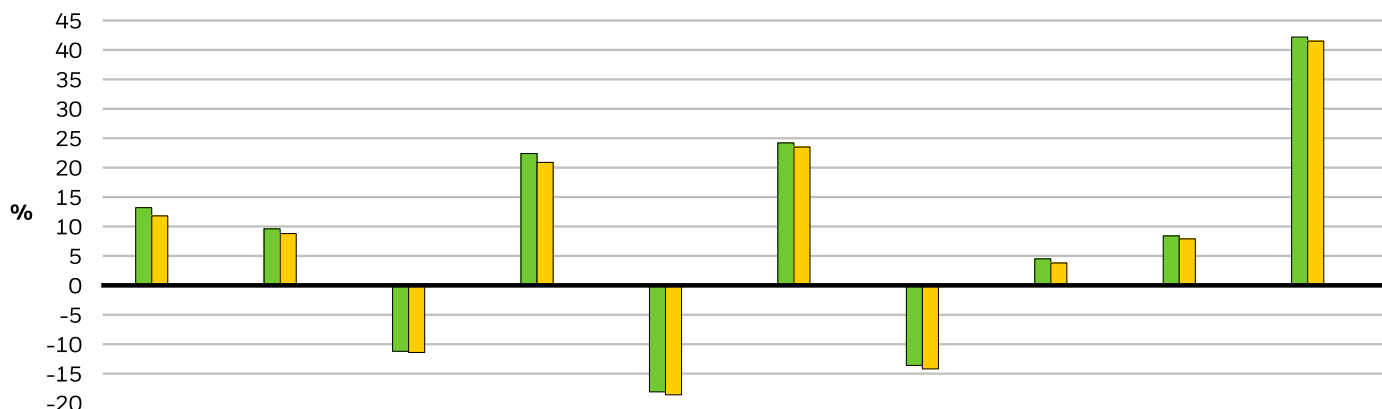

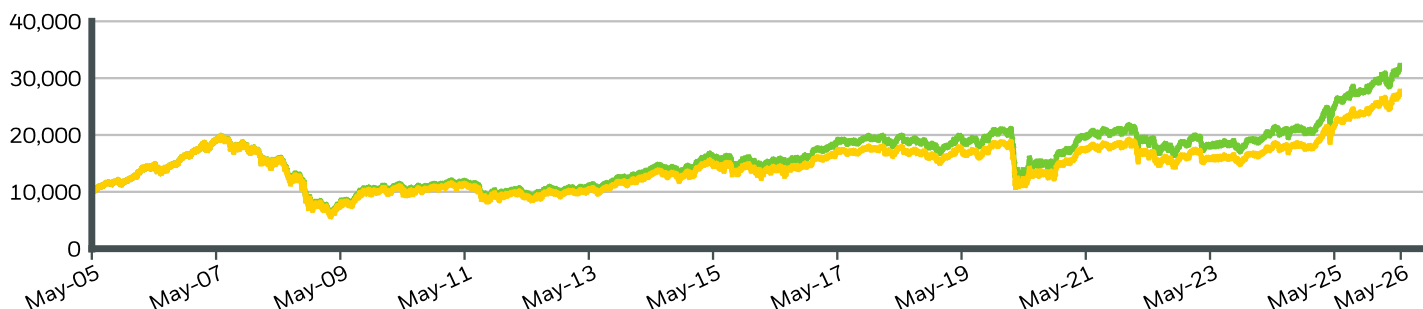

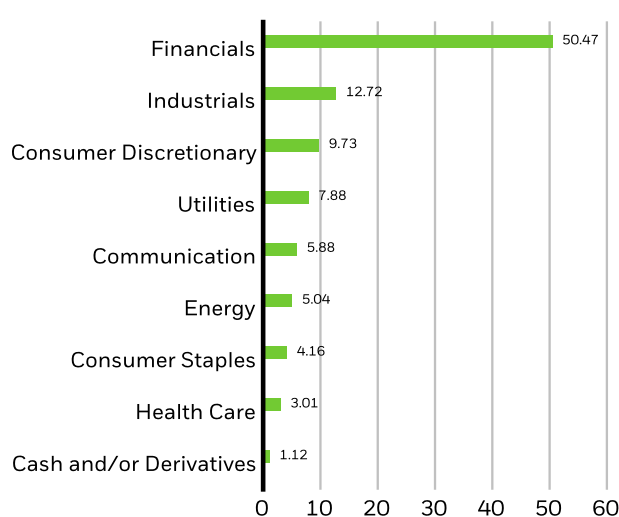

SECTOR BREAKDOWN (%)



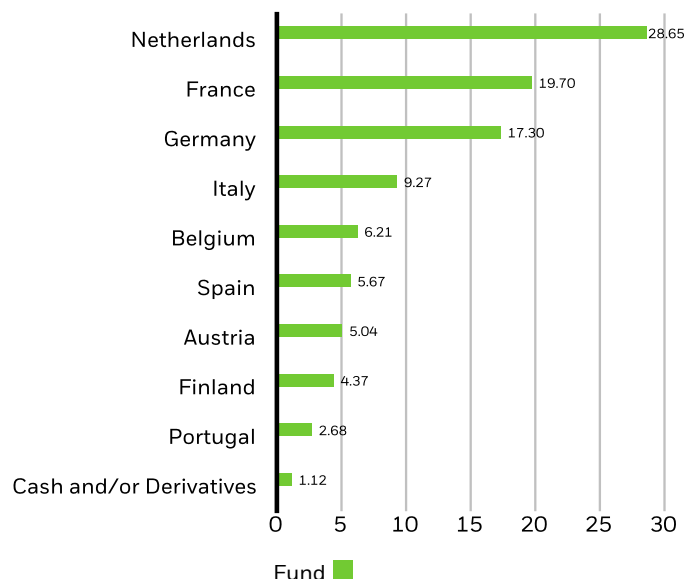
