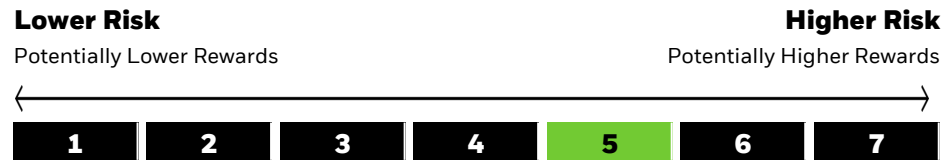
FUND OVERVIEW

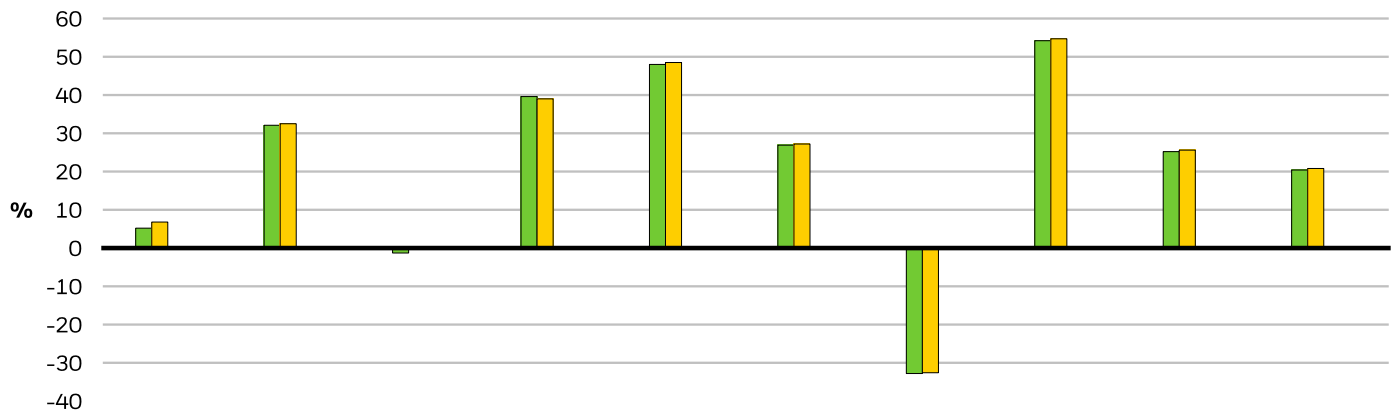

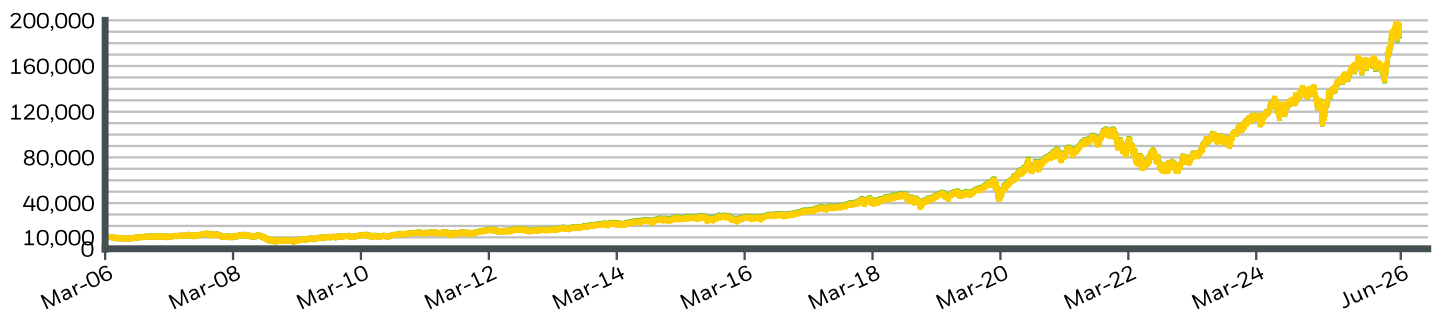

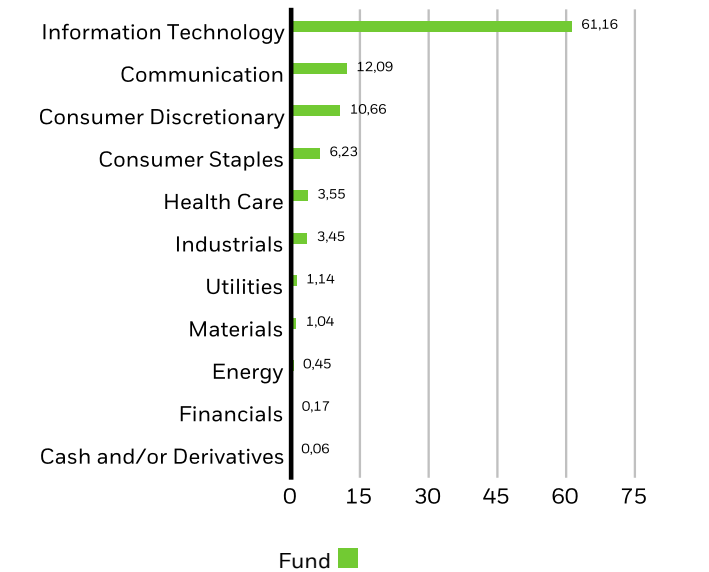
