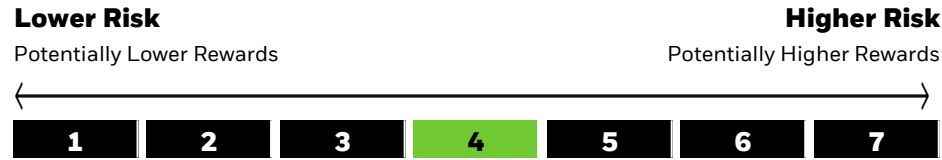
FUND OVERVIEW

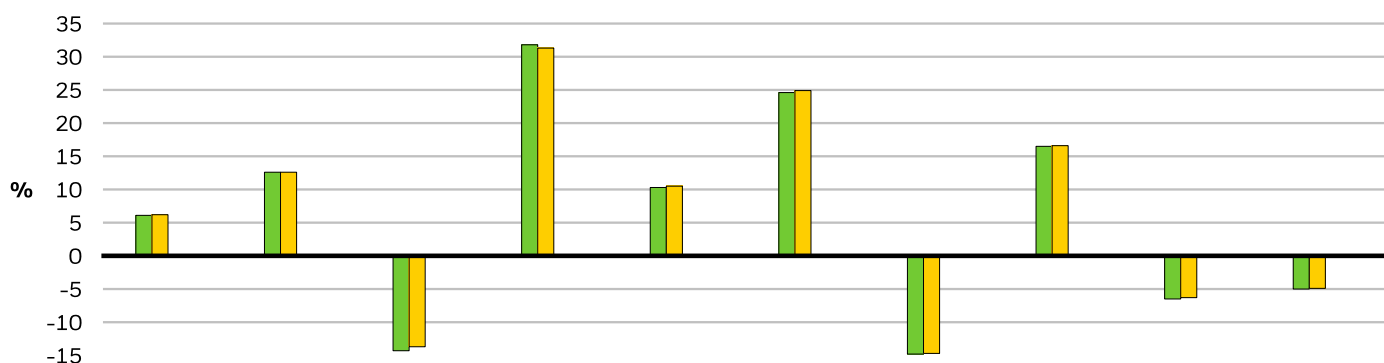

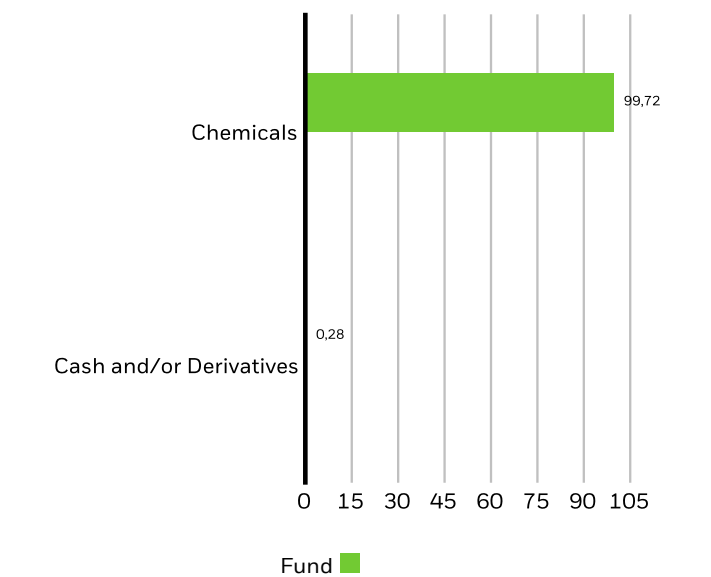

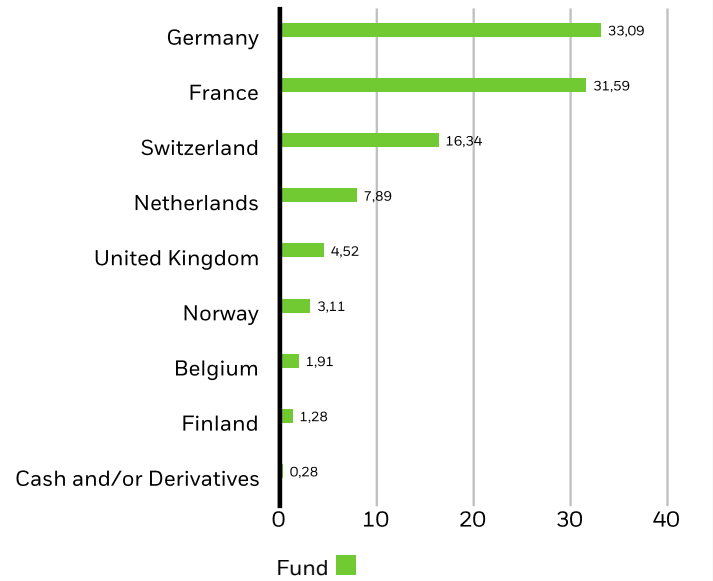

GLOSSARY
