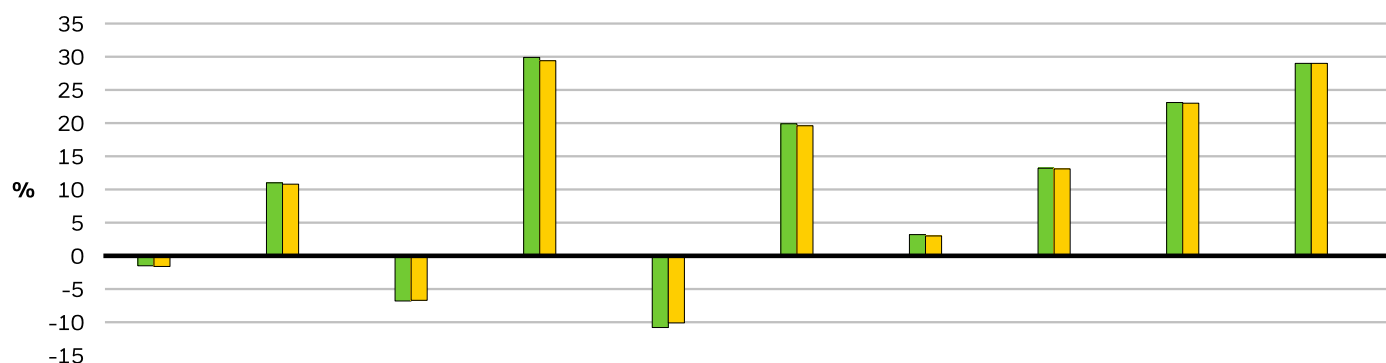

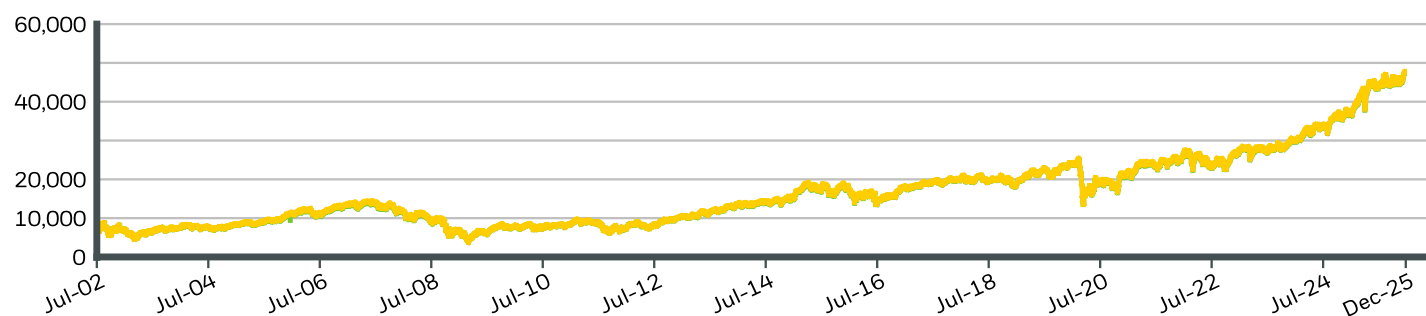

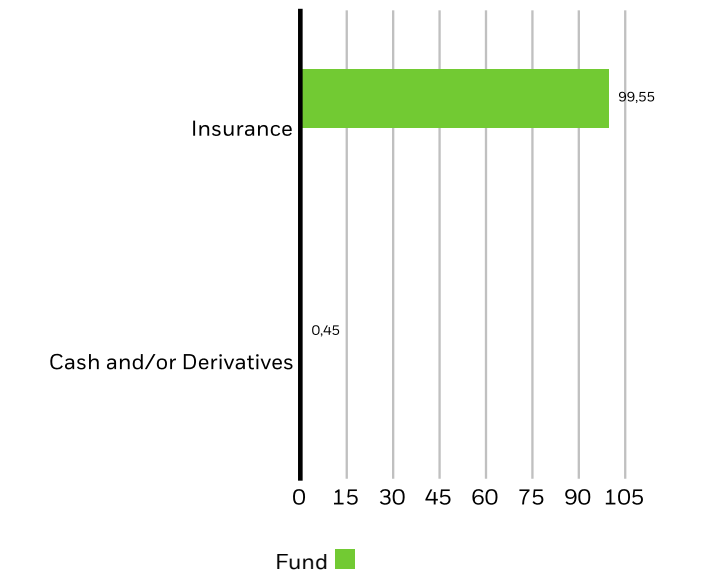

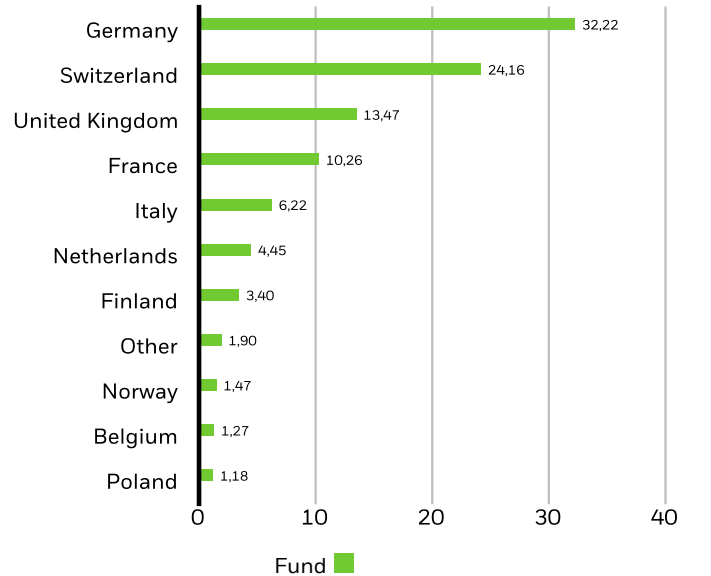

GLOSSARY
