**Investment objective:** The objective of the Sub-Fund is to achieve a long-term return in excess of S&P 500 (Total Return Net) ("the Benchmark") by actively investing primarily in a portfolio of US companies.

**Investment policy:** The Sub-Fund pursues an actively-managed investment strategy.

**Investment approach**

- Invests primarily in a diversified portfolio of equity securities of large capitalization U.S. companies.
- Employs a research-driven approach leveraging the insights of the analyst platform that focuses on identifying the most undervalued stocks in each sector.
- Maintains sector weightings similar to the S&P 500 Index, seeking to outperform over long-term.
- Applies values and norms based screening and implements minimum investment thresholds on companies with positive ESG characteristics.

**Investor profile:** Typical investors in the Sub-Fund are expected to be investors seeking broad exposure to the US equity market, and who are prepared to accept the risks associated with an investment of this type, including the volatility of such an investment approach.

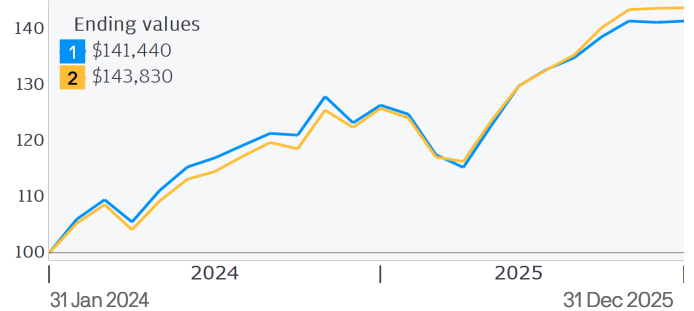

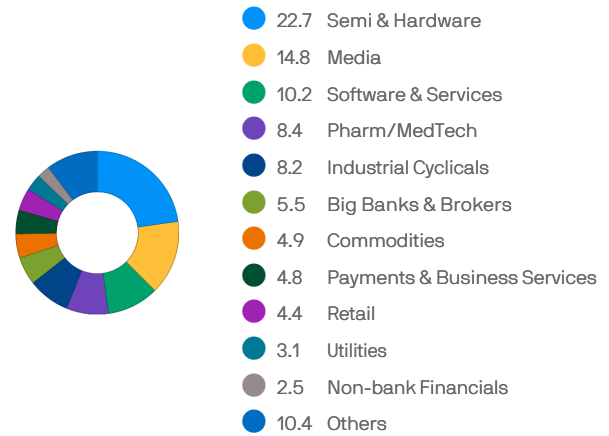
