<b>Investment policy:</b> The Sub-Fund pursues an actively-managed investment strategy.

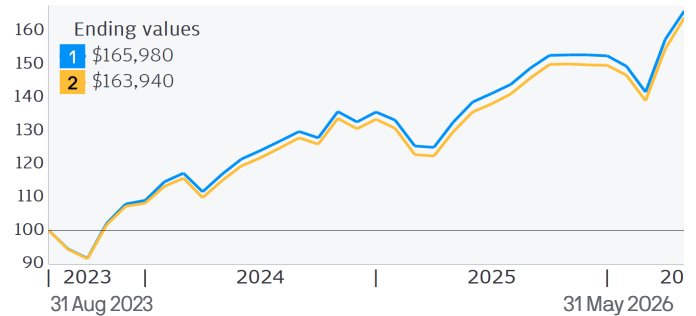

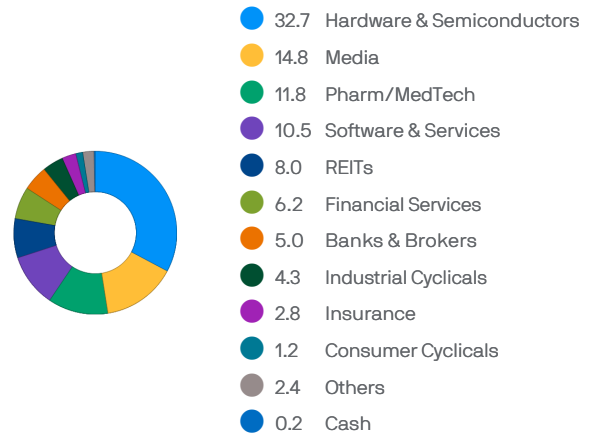
