Investment objective: The objective of the Sub-Fund is to achieve a long-term return in excess of Bloomberg Euro Aggregate Treasury Total Return Index ("the Benchmark") by actively investing primarily in a portfolio of EUR denominated government and government related debt securities.		
Investment policy: The Sub-Fund pursues an actively-managed investment strategy.		
Investment approach • Uses a globally integrated research driven investment process that focuses on analysing fundamental, quantitative and technical factors across countries, sectors and issuers. • Targets diversified sources of portfolio return – including duration management, yield curve positioning, cross markets trades, inflation and high quality non-corporate credit exposure. • Invests in EUR denominated government and government related debt.		
Investor profile: Typical investors in the Sub-Fund are expected to be those who seek exposure to the market covered by the Benchmark and a broadly diversified EUR denominated government bond investment with positive environmental and/or social characteristics that follow good governance practices and an overlay of ESG integration and values and norms-based screening of its investment universe.

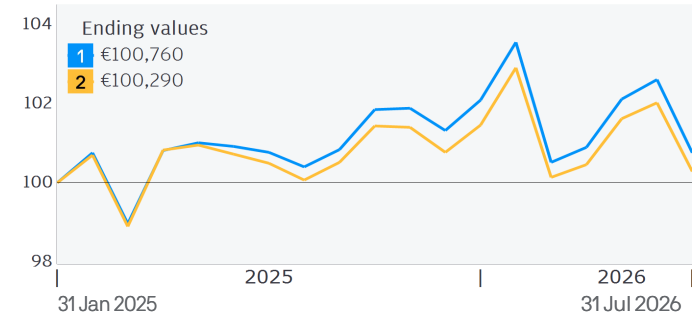

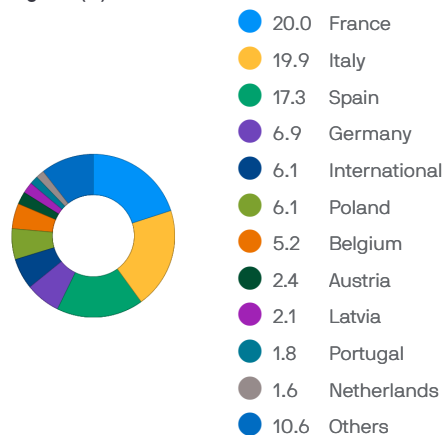

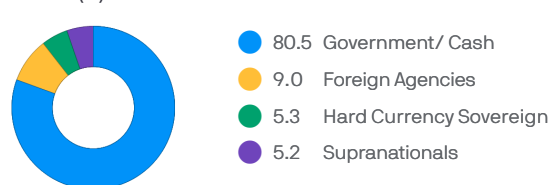
