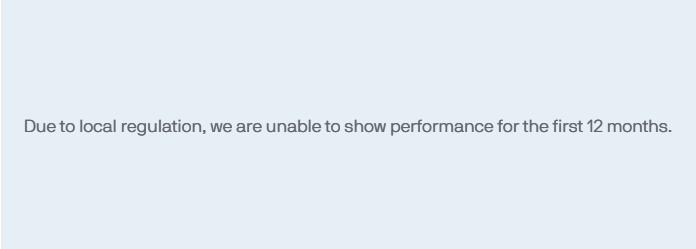

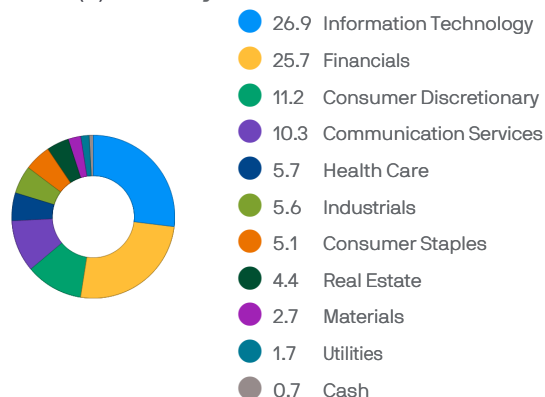

Key risks
