Investment policy: The Sub-Fund pursues an actively-managed investment strategy.

Investment approach

- Uses a fundamental, bottom-up stock selection process.
- Enhanced index approach that builds a portfolio in reference to a Paris Aligned Benchmark by overweighting securities with the highest potential to outperform and underweighting securities considered
- Diversified portfolio with disciplined, risk-controlled portfolio construction while retaining the decarbonisation objectives of the Paris agreement.
- Applies values and norms-based screening to implement exclusions.

Investor profile: Typical investors in the Sub-Fund are expected to be investors who want to take broad market exposure to global emerging markets, who seek to benefit from potential excess returns with similar risks to investing in securities representing the Benchmark and who are prepared to accept the risks associated with an investment of this type, including the volatility of such market.


