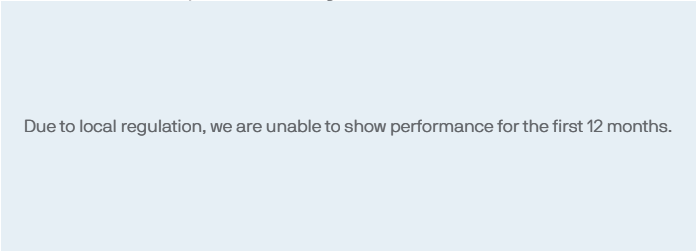

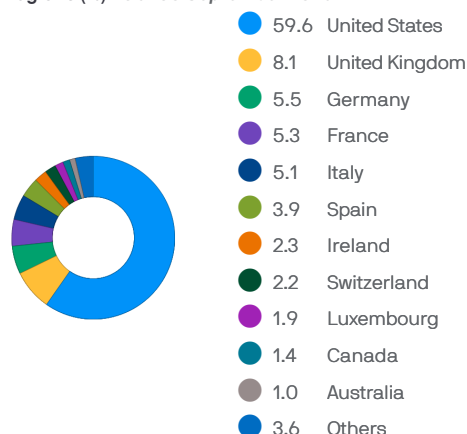

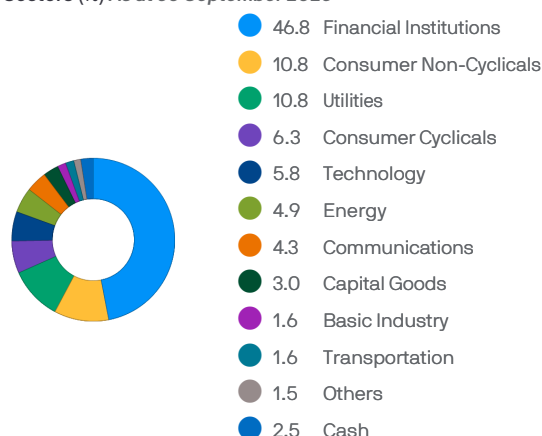

Key risks
