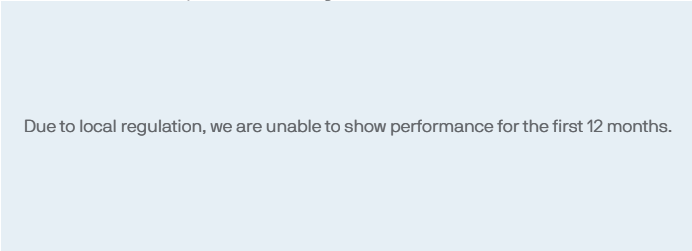

## Key risks
