Fund aim

The L&G Emerging Markets Government Bond (USD) 0-5 Year Screened UCITS ETF (the "ETF") aims to track the performance of the J.P. Morgan ESG EMBI Global Diversified Short-Term Custom Maturity Index (the "Index"). More information on the Index can be found on page 2 of this document.

Fund snapshot

- The L&G Emerging Markets Government Bond (USD) 0-5 Year Screened UCITS ETF aims to provide exposure to the US Dollar-denominated government bond market across emerging markets.
- The Fund will invest more in companies with higher ESG scores, and will also invest in companies with lower ESG scores, but by a reduced amount.
- Does it promote sustainability characteristics? The Fund promotes a range of environmental and social characteristics which are met by tracking the Index. Further information on how such characteristics are met by the Fund can be found in the Fund Supplement.

Who is this fund for?

- The ETF is designed for investors looking for a combination of growth and income from an investment in liquid, US Dollar-denominated emerging market fixed and floating-rate government and quasi government bonds, maturing within the next 3 months to 5 years which can form part of their existing savings portfolio.
- Although investors can take their money out at any time, this ETF may not be appropriate for those who plan to withdraw their money within five years.
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment.
- If you do not understand the information in this document, the key information document or the prospectus, we recommend that you seek additional information or advice to help you decide if this ETF is suitable for you.

Index description

The Index tracks liquid, US Dollar-denominated emerging market fixed and floating-rate debt instruments issued by sovereign and quasi-sovereign entities, maturing within the next 3 months to 5 years. The index applies an ESG scoring and screening methodology to tilt toward issuers ranked higher on ESG criteria and green bond issues, and to underweight and remove issuers that rank lower.

Index fund management team
