# **Short Palantir ETP**



The Leverage Shares -1x Short Palantir ETP Securities seeks to track the iSTOXX Inverse Leveraged -1x PLTR Index, which is designed to provide -1x the daily return of Palantir Technologies Inc. stock, adjusted to reflect the fees and inherent costs and revenues of shorting. It holds the short positions in the underlying Palantir Technologies Inc. stock and resulting cash balances.

For example, if Palantir Technologies Inc. rises by 1% over a day, then the ETP will fall by 1%, excluding fees. However, if Palantir Technologies Inc. falls by 1% over a day, then the ETP will rise by 1%, excluding fees.

## Key Features
