In-line with UCITS guidelines, the exposure to the counterparty cannot exceed 10% of the total fund assets. UNDERLYING RISK : The Underlying Index of a Amundi ETF may be complex and volatile. 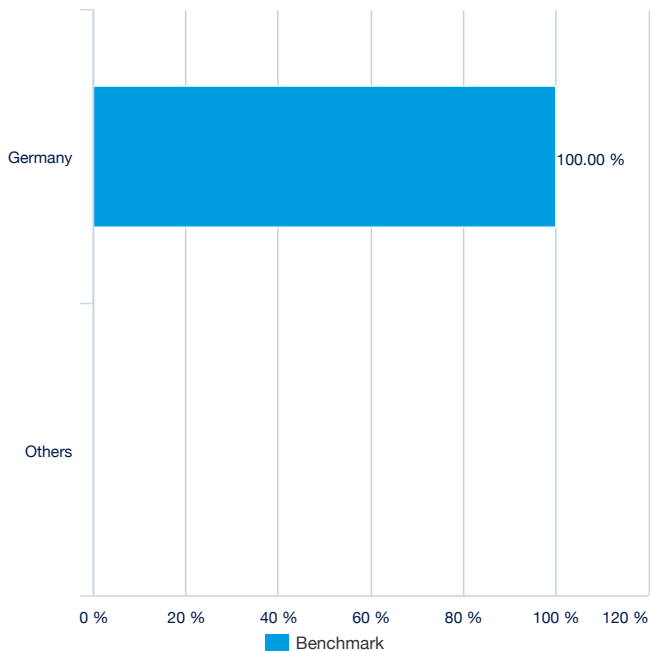

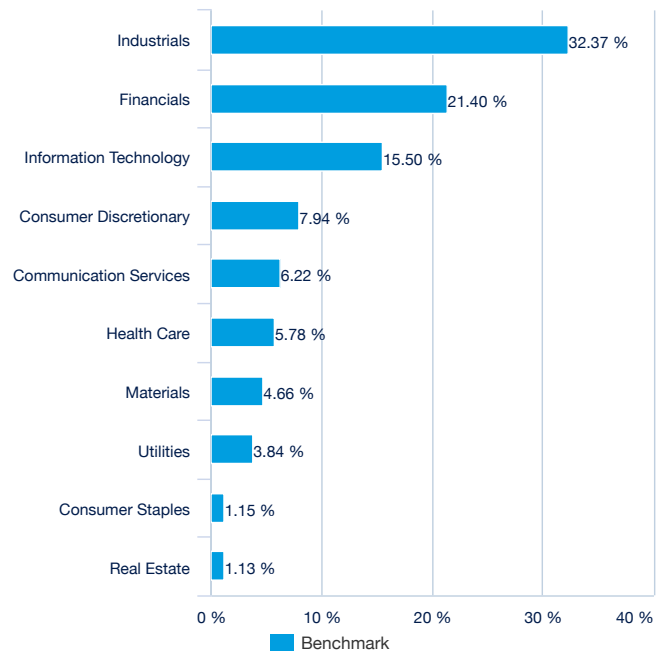
