## Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of MSCI ACWI IMI Future Mobility ESG Filtered Index (the "Index") and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The anticipated level of the tracking error, under normal market conditions is indicated in the prospectus of the Sub-Fund.




