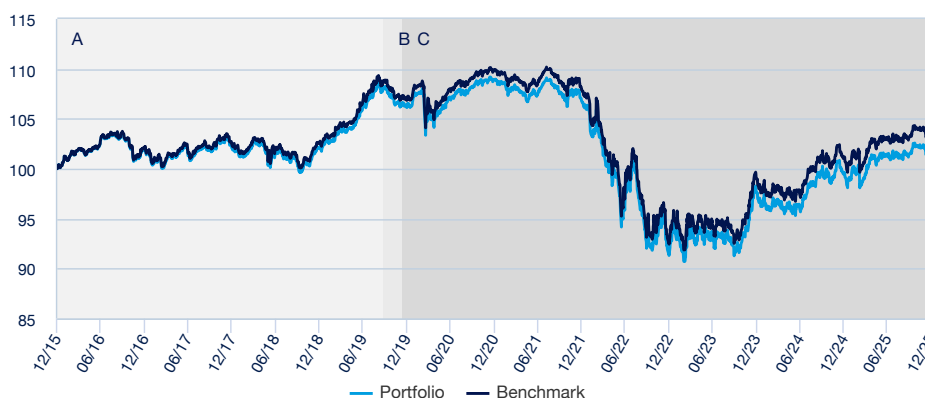

Description of the Index

Eligible securities must have maturities of at least 5 years and no more than 7 years, with a minimum outstanding amount of €300m.

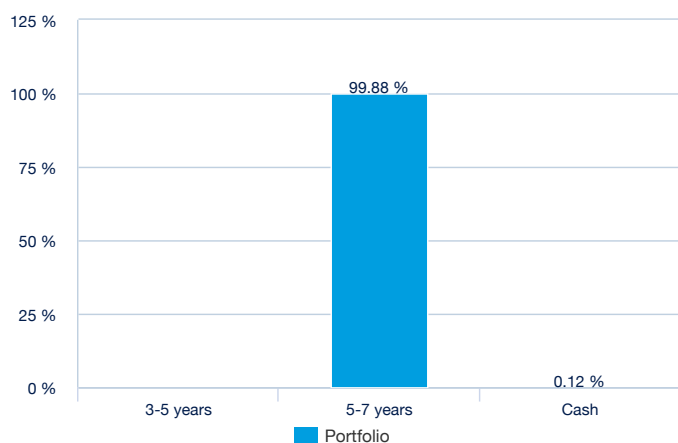

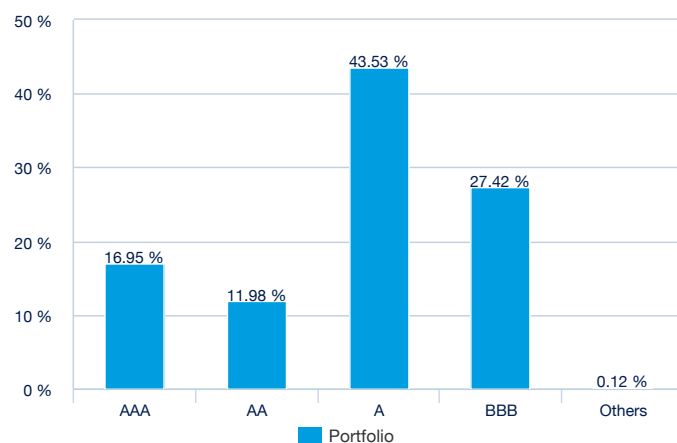

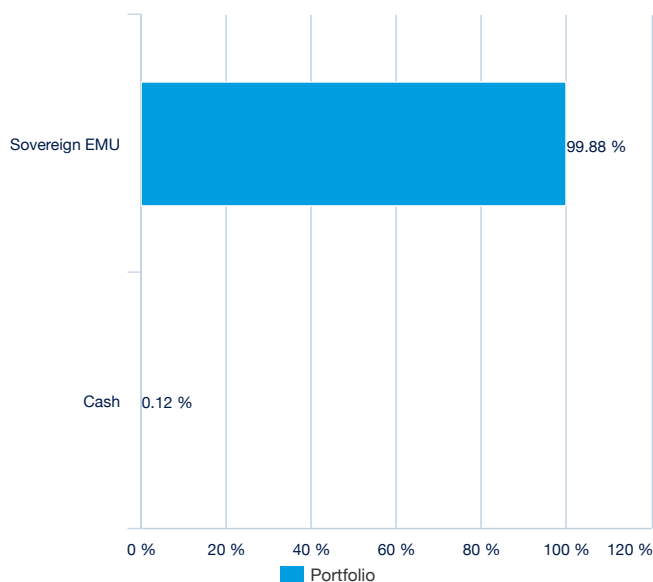
By maturity (Source: Amundi)



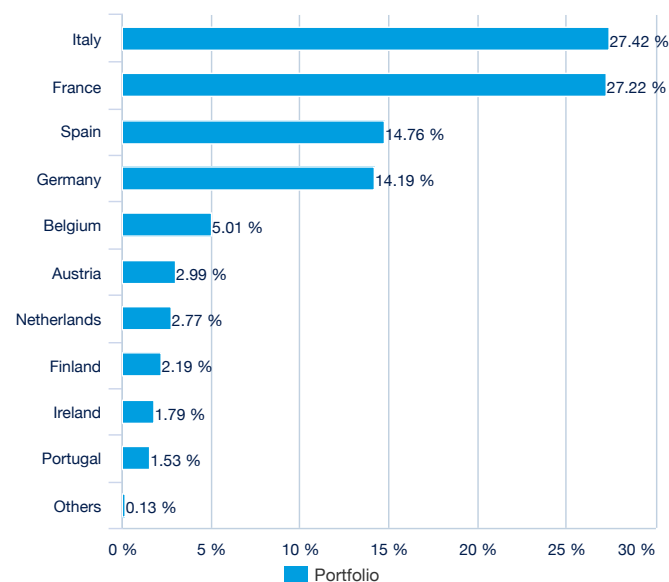
