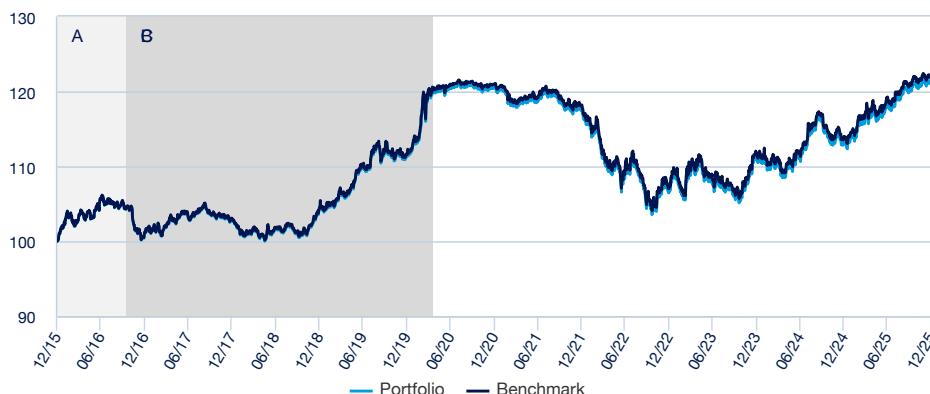

UNDERLYING RISK : The Underlying Index of a Amundi ETF may be complex and volatile. 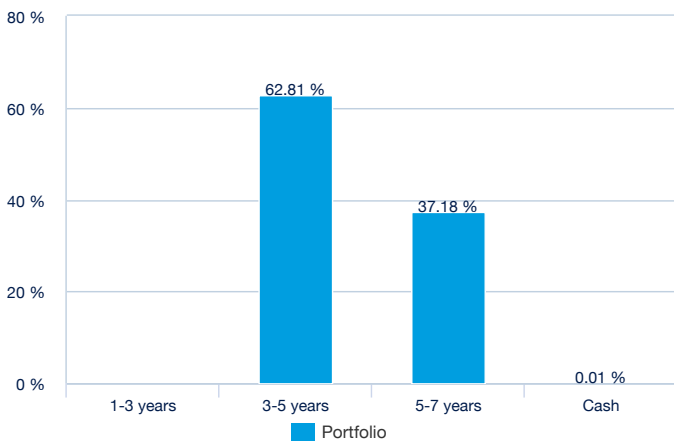

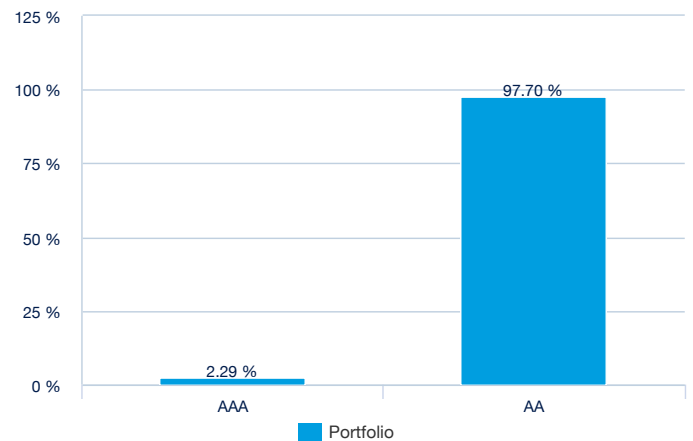

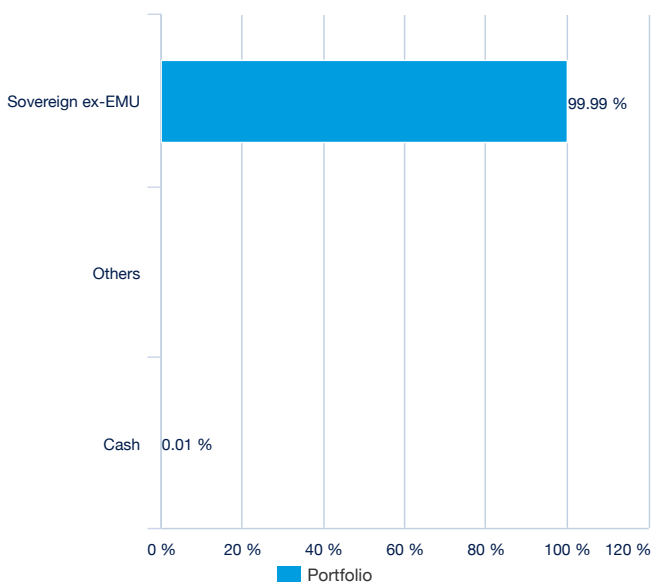
By maturity (Source: Amundi)



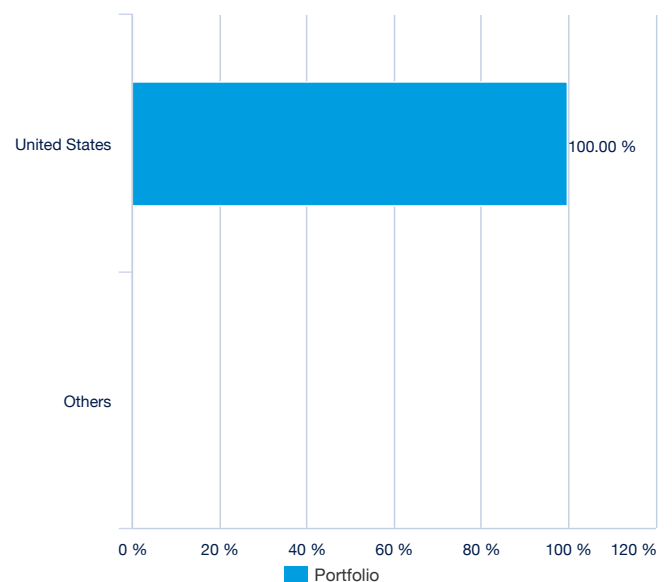
