INDEX DESCRIPTION:

The index was created by S&P in 1957 and includes the dividends generated by the equities comprising it. Its Bloomberg code is SPTR500N Index.

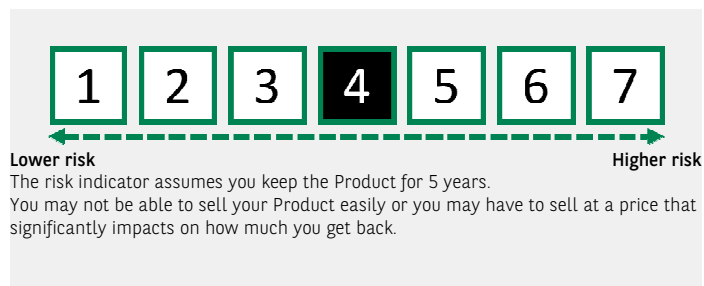

Tracking Error

The tracking error measures the volatility of a portfolio's relative return in relation to its benchmark index.
