At a Glance

- The Xtrackers Physical Platinum EUR Hedged ETC provides investors with direct price exposure to physical platinum
- Physically backed by platinum bars that meet London Good Delivery standards and are accredited by the LBMA (London Bullion Market Association)
 - Platinum is stored securely in allocated form in high-security vaults located in London
 - Each ETC security issued is fully collateralised by a corresponding amount of physical platinum, known as the metal entitlement
 - Daily hedging mechanism designed to minimize currency risk

Physical

Xtrackers Physical Platinum EUR Hedged ETC are backed by a Direct investment in the underlying physical platinum. The issuer is the direct and sole owner of the platinum, which is held in Collateral accounts. Each physical ETC security entitles the holder to receive a specified quantity of platinum (the "Metal entitlement") from the issuer's segregated pool. The value of the security is derived from the metal entitlement, the platinum spot price and any applicable fees. Xtrackers Physical Platinum EUR Hedged ETC combine the benefits of physical ownership of platinum, such as participation in platinum spot prices and minimal default risk, with the liquidity, transparency and ease of execution typical of exchange-traded products. Settlement of the ETC securities takes place in cash. No physical metal is delivered to holders of ETC securities on the secondary market, i.e. to holders who are not Authorised Participants.

Limited-Recourse

For each series of ETC securities, the underlying physical platinum (Secured Assets) is owned by the issuer and is held via the custodian of the collateral account. In addition, it is charged in favour of the trustee in the name of the securityholders. Each series of ETC securities has recourse only to the secured assets relating to that series, after the relevant service providers have received all outstanding amounts relating to that series. These secured assets are not available to satisfy claims relating to any other series of ETC securities (the "ring-fencing principle").

Key Advantages

- Convenient investment option: A simple way to participate in the spot returns of the underlying platinum. The ETC structure fits seamlessly into traditional brokerage accounts and portfolio management structures without the need to open a precious metals account.
- Liquidity of Xtrackers ETC: The securities are traded intraday on major European exchanges with intraday market making.
- Minimal tracking error: The returns of the ETC securities correspond to the spot returns of the underlying metal, less fees.
- Physical collateralisation: The ETC securities are physically backed by the corresponding platinum, which is held in secure vaults.
- Transparent value: Precious metal prices are published on the Xtrackers website and in other news sources.
- Segregation: The physical metal is held in secure vaults and each ETC series is secured via a separate metal account with the custodian.
- Currency hedging: Xtrackers Physical Platinum EUR Hedged ETC is equipped with a daily currency hedging mechanism to minimise EUR/USD exchange rate risk.

Key Risks
