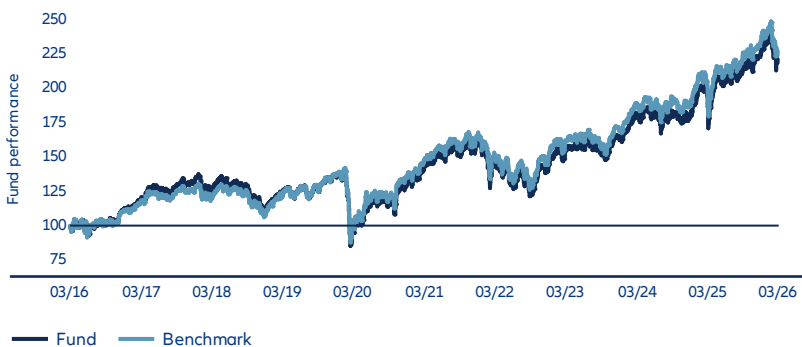

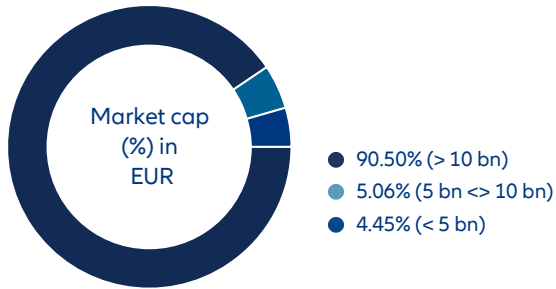

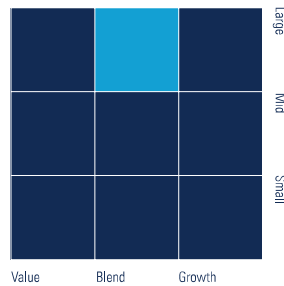

12) Volatility measures the fluctuation range of the fund's performance over a specified period of time
