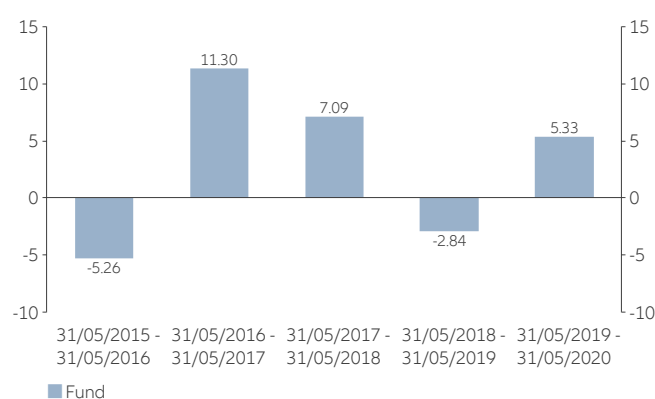

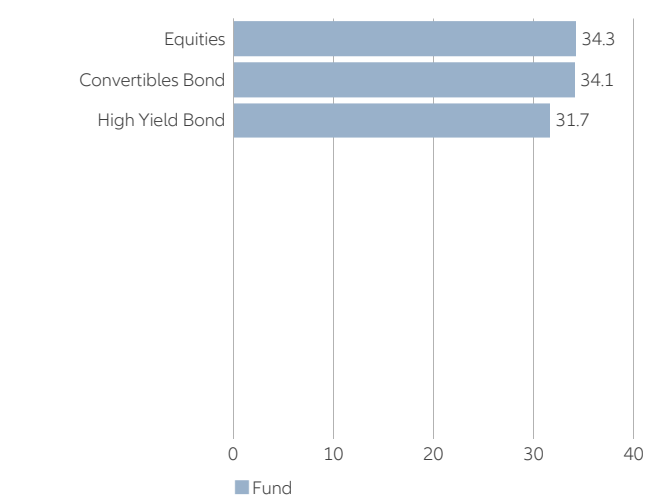

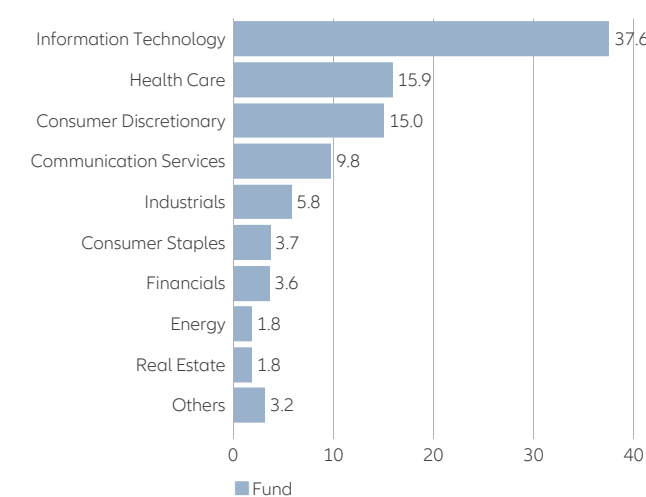
Asset Allocation Breakdown (%)



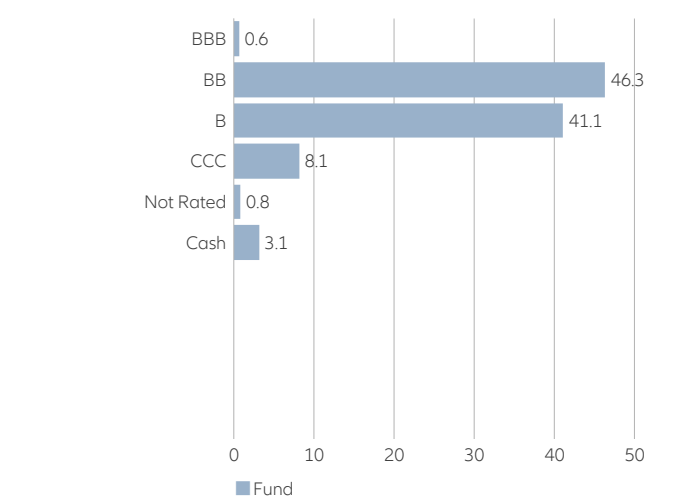
