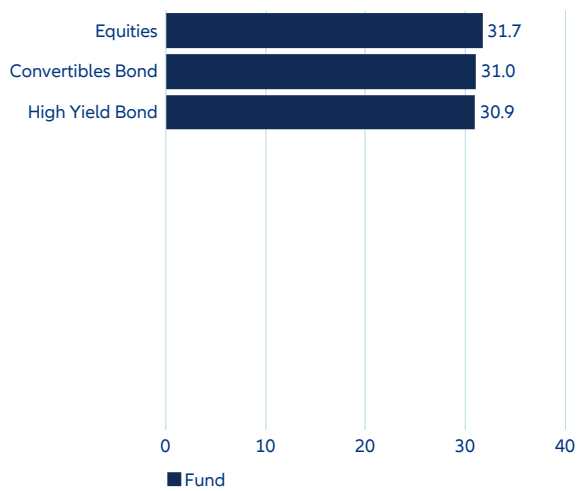

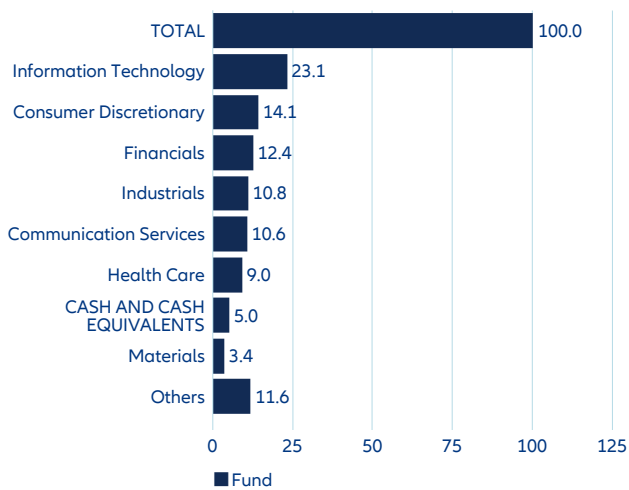
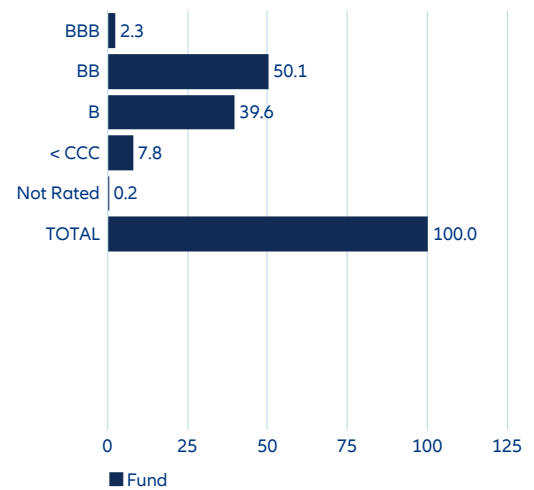
Portfolio Structure ⁵
