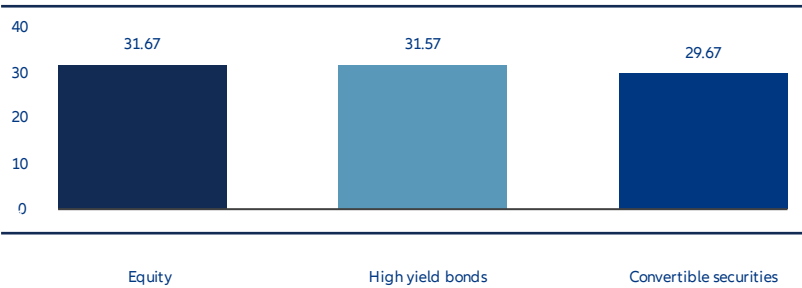

Asset allocation (%)¹¹



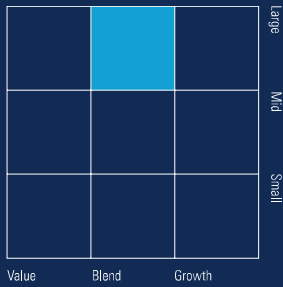
