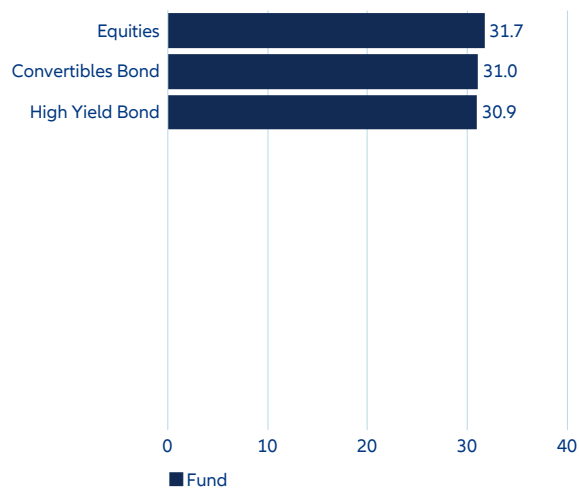

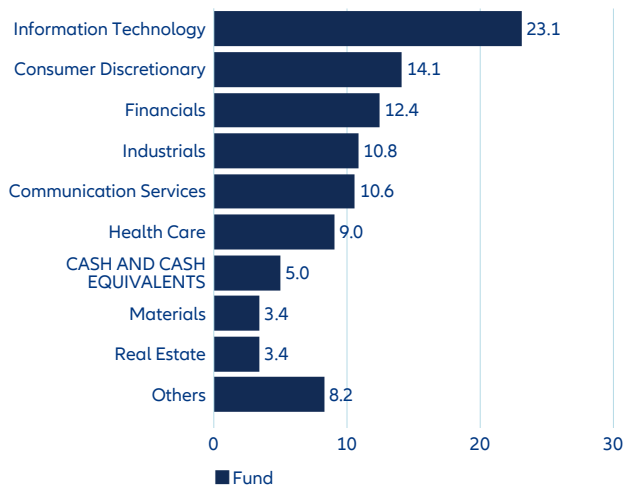
Asset Allocation Breakdown (%)



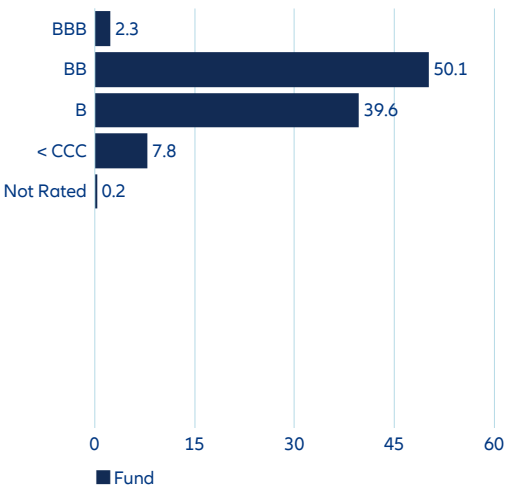
