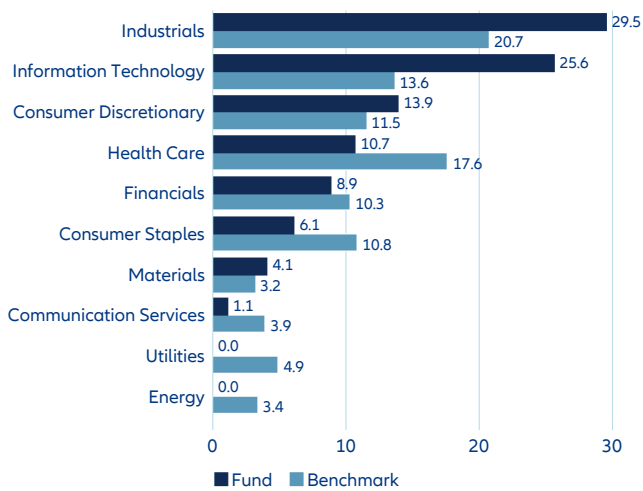

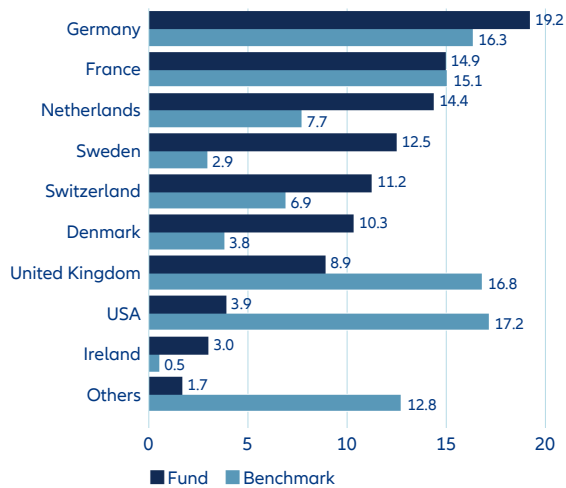
Portfolio Structure <sup>7</sup>
