Fund for convertible bonds focusing on Europe

Investment Objective

The fund invests primarily in convertible bonds with emphasis on securities traded in Europe. Up to 20 % of the fund's assets may be invested in convertible bonds issued in an Emerging Markets country. Stocks may be acquired on exerting conversion, subscription and option rights. The fund's aim is to generate capital growth over the long term. Sustainability aspects are taken into account by the fund management. 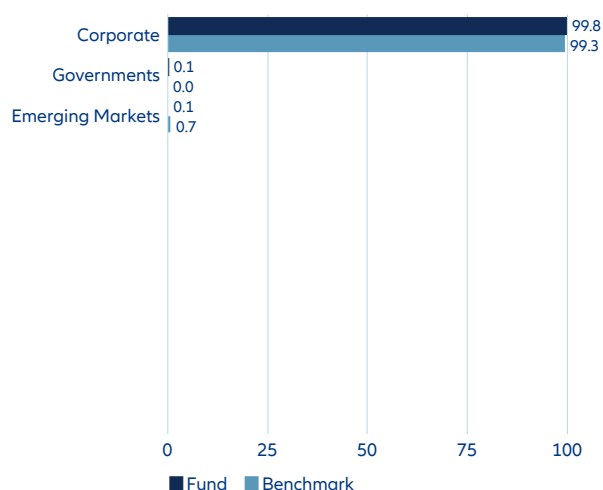
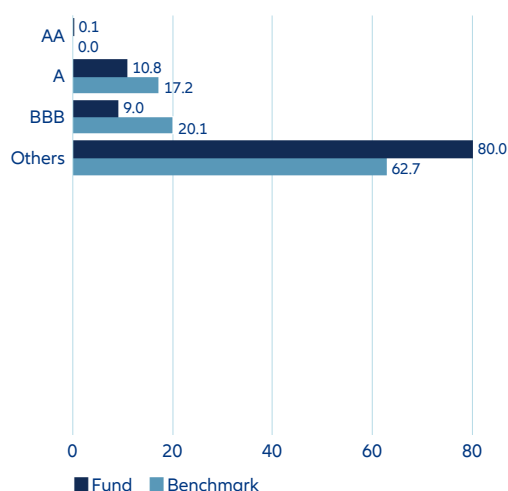

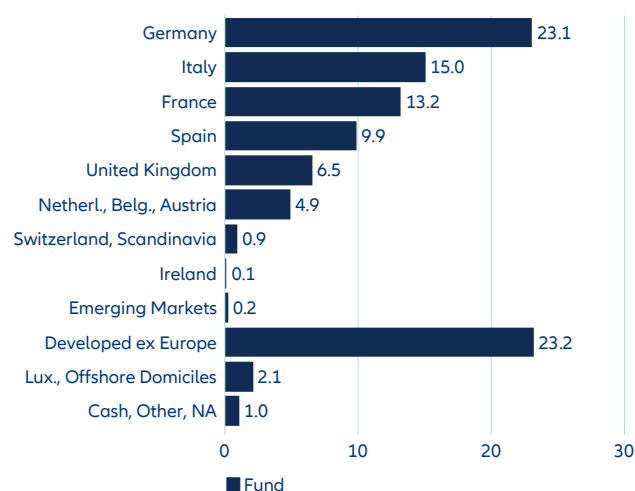
