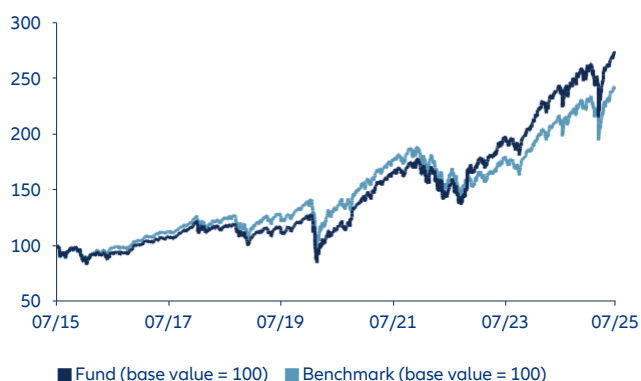

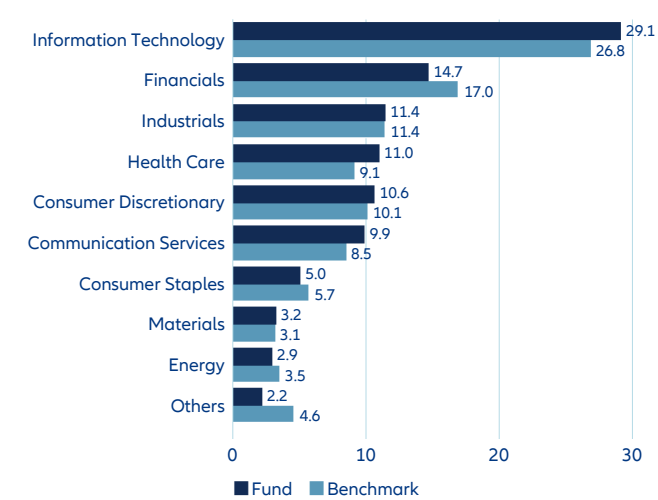

Portfolio Structure ⁶

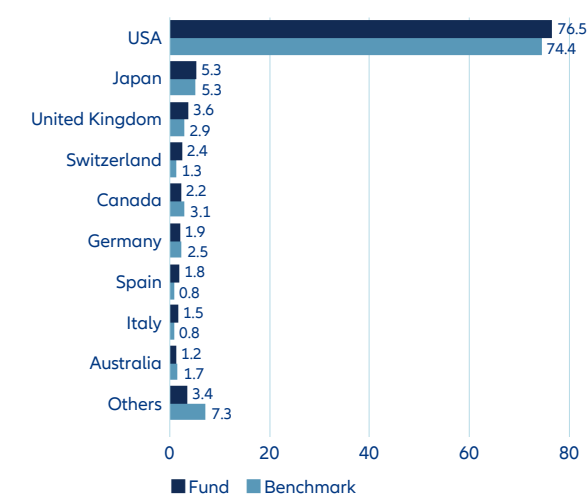
Sector Breakdown (%)
