The fund's investment objective is to attain capital growth over the long-term.

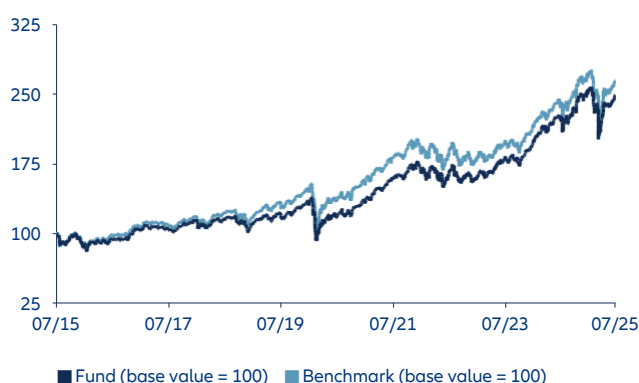

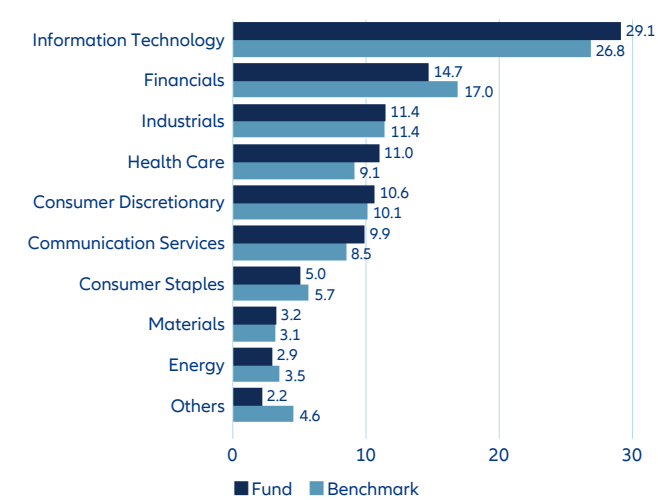

Portfolio Structure ⁶

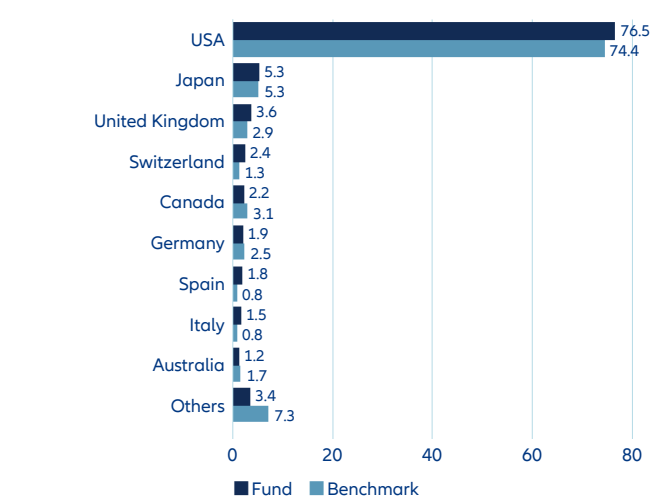
Sector Breakdown (%)
