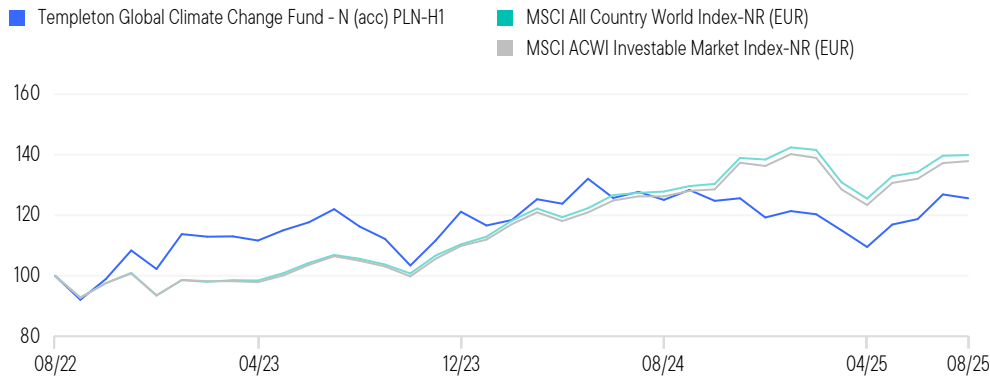

Investment Overview

To seek long-term investment growth, mainly through growth of capital, while contributing to climate change mitigation and adaptation. The Fund also aims to achieve greenhouse gas (GHG) reductions aligned with the Paris Climate Agreement's long-term global warming target of 1.5 degrees. The Fund mainly invests in equities of companies that help reduce carbon emissions, improve resource efficiencies or limit the physical consequences of climate change. These investments may include such sectors as renewable energy, energy distribution, green materials and recycling, as well as individual companies that already have low carbon emissions or are making industry-leading efforts to reduce them. These investments may be from anywhere in the world.

Glossary

Ongoing Charges Figure (OCF): The Ongoing Charges Figure (OCF) includes the fees paid to the management company, the investment manager and the depository, as well as certain other expenses. The OCF is calculated by taking the relevant main material costs paid out over the 12-month period indicated and dividing them by the average net assets over the same period. The OCF does not include all expenses paid by the fund (for example, it does not include what the fund pays for buying and selling securities). For a portfolio, the value represents a weighted average based on the stocks held. **Price to Book:** The price per share of a stock divided by its book value (i.e., net worth) per share. For a portfolio, the value represents a weighted average of the stocks it holds. **Price to Earnings (12-Month Trailing)** is the share price of a stock, divided by its per-share earnings over the past year. For a portfolio, the value represents a weighted average of the stocks it holds. **Price to Cash Flow:** Supplements price/earnings ratio as a measure of relative value for a stock. For a portfolio, the value represents a weighted average of the stocks it holds. **Standard Deviation:** Measure of the degree to which a fund's return varies from the average of its previous returns. The larger the standard deviation, the greater the likelihood (and risk) that a fund's performance will fluctuate from the average return.

As a result, the returns shown above reflect the effect of the hedging strategy and one can compare the returns of the Fund (net of fees) relative to its benchmark index without the impact of exchange rate movements on index returns.
