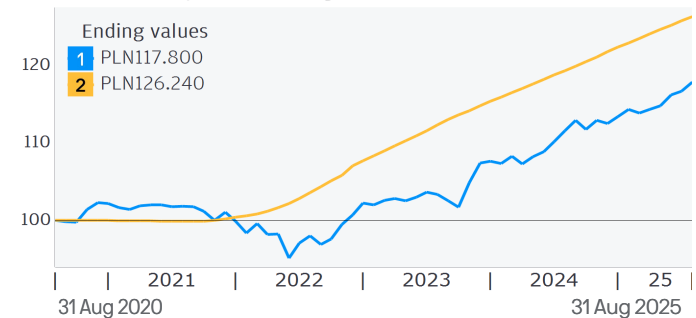

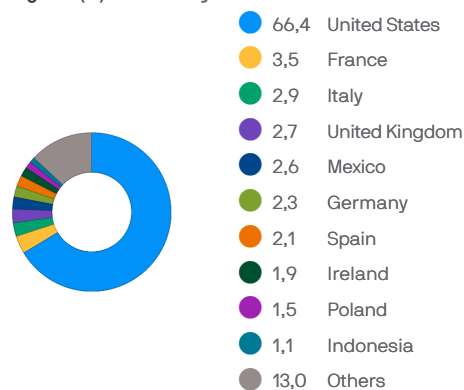

Definitions

NAV Net Asset Value of a fund's assets less its liabilities per Share.

Annualised volatility (%) measures the extent to which returns vary up and down over a given period.
