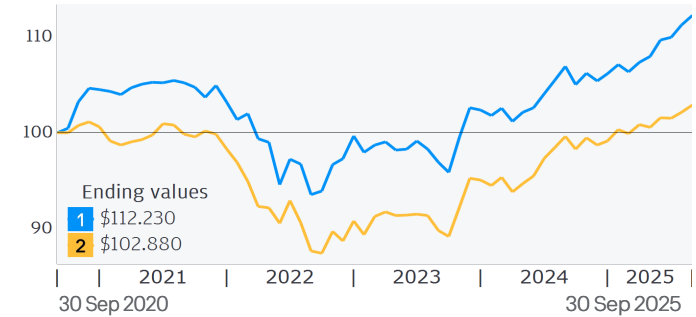

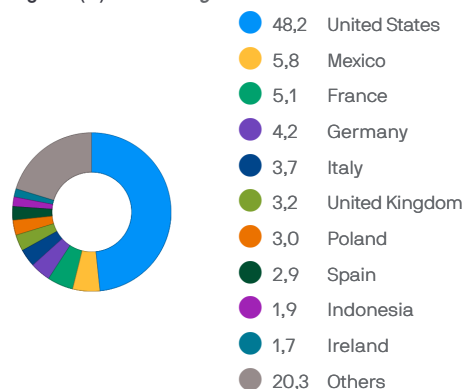

Definitions
