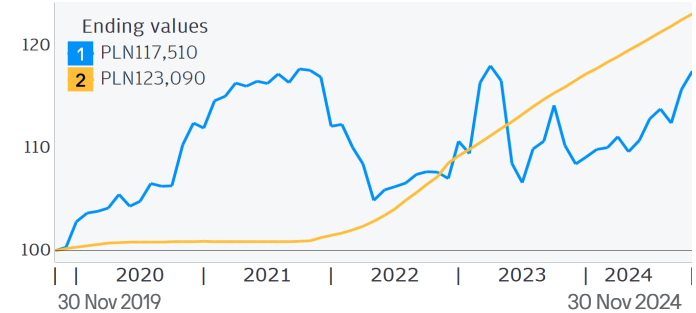

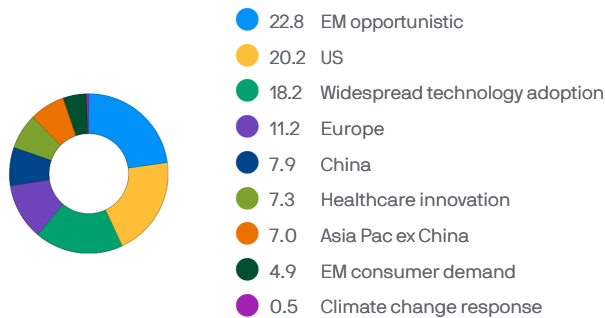

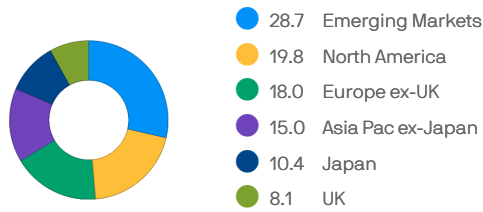

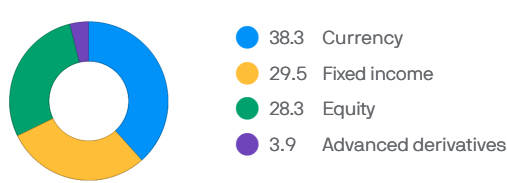
Theme Risk Breakdown (%)

Definitions
