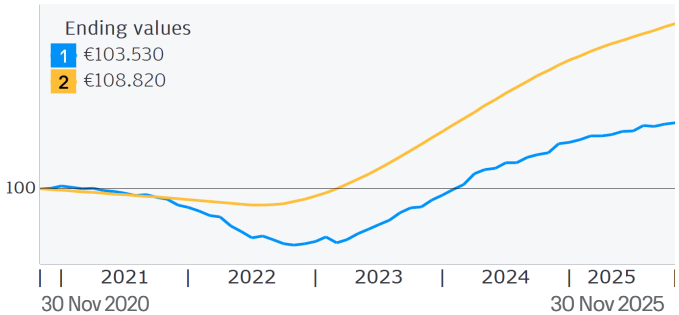

Definitions
