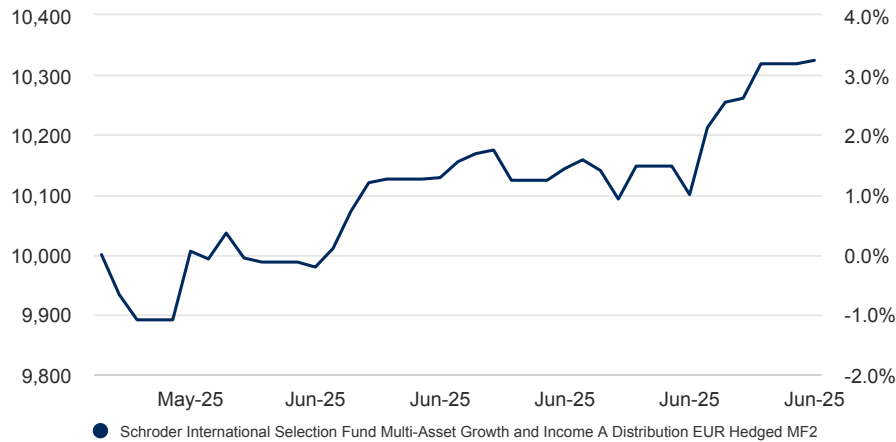

Return of EUR 10,000

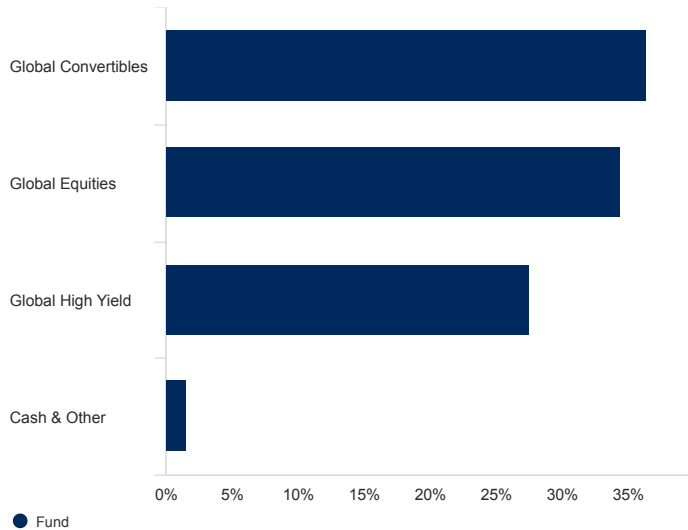

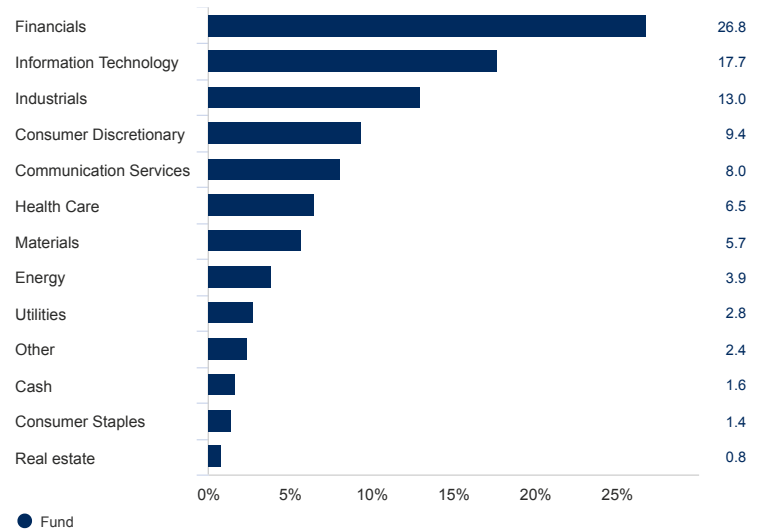

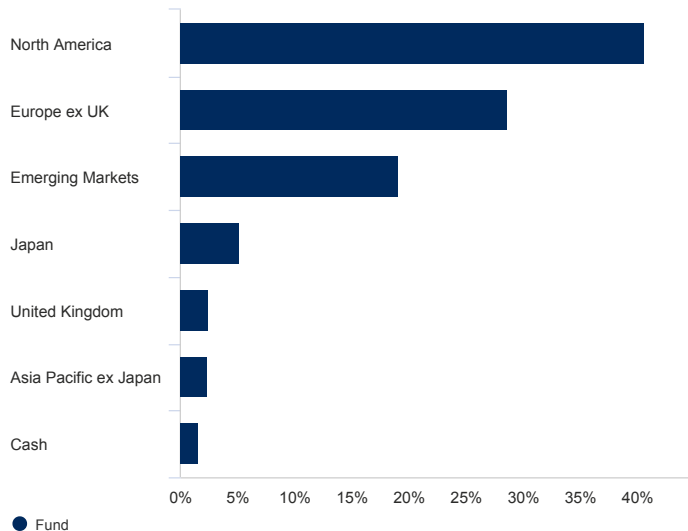
