Investment Objective and Policy

The fund aims to provide capital growth by investing in equities of Brazilian, Russian, Indian and Chinese companies

The fund invests at least two-thirds of its assets in a range of equities of companies in the MSCI BRIC index. The fund typically holds 25-50 companies. The fund is managed with reference to material environmental, social and governance factors. This means issues such as climate change, environmental performance, labour standards or board composition that could impact a company's value may be considered in the assessment of companies. The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently. The fund may also hold cash.

Risk Considerations


