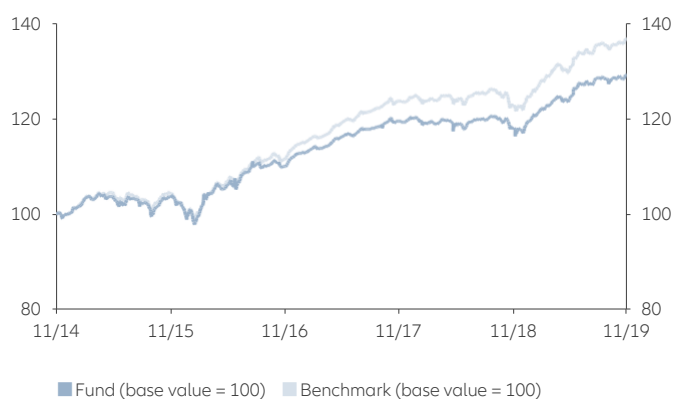

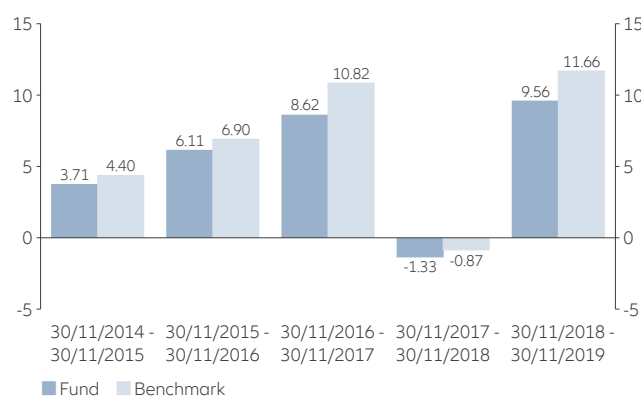

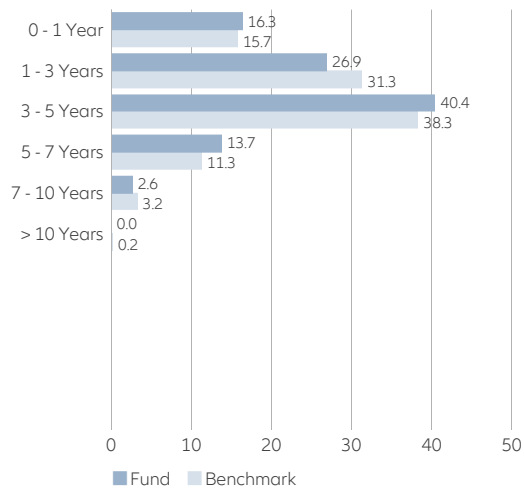

## Portfolio Structure <sup>4</sup>

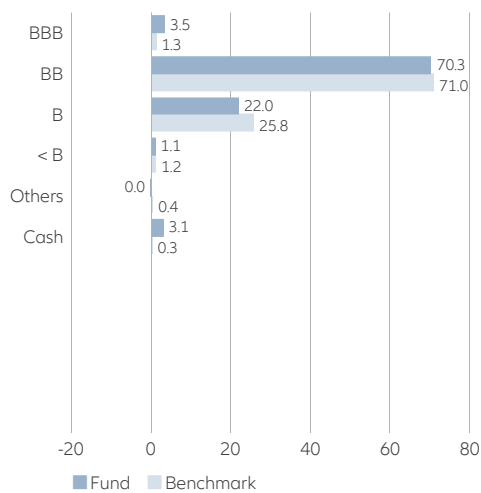
Duration Breakdown (%) (weighted by market value)



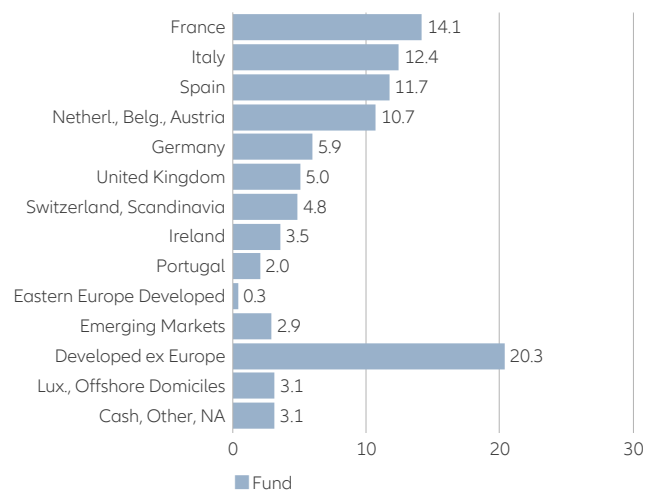
