Risk considerations

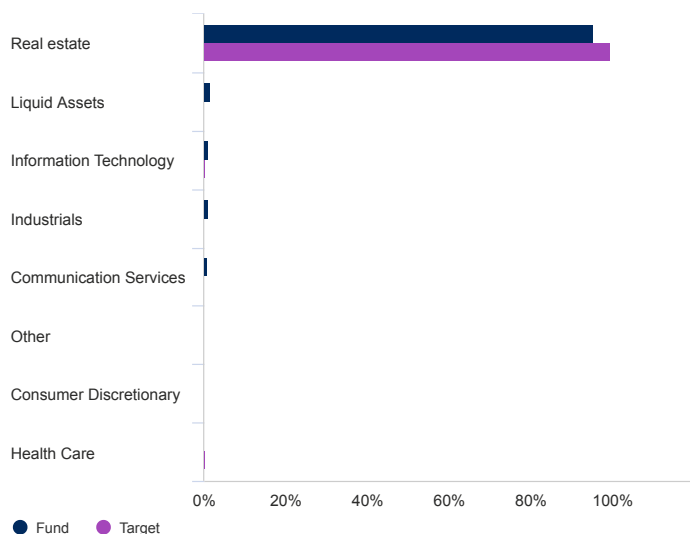

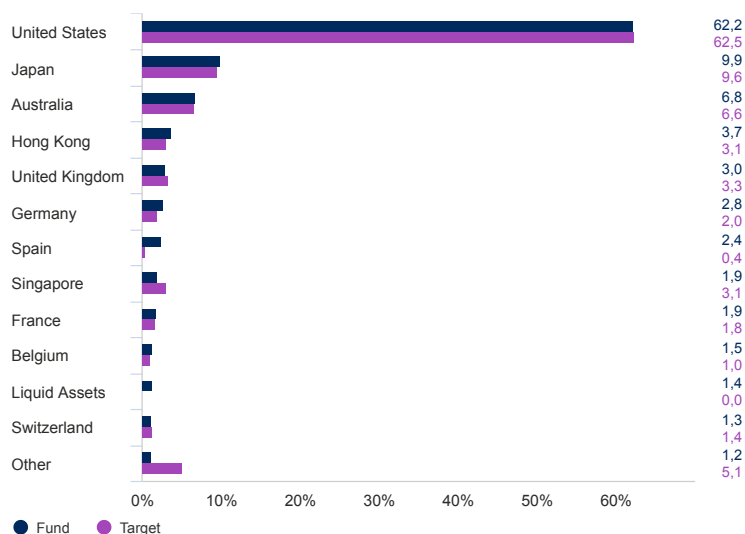

Sector (%)

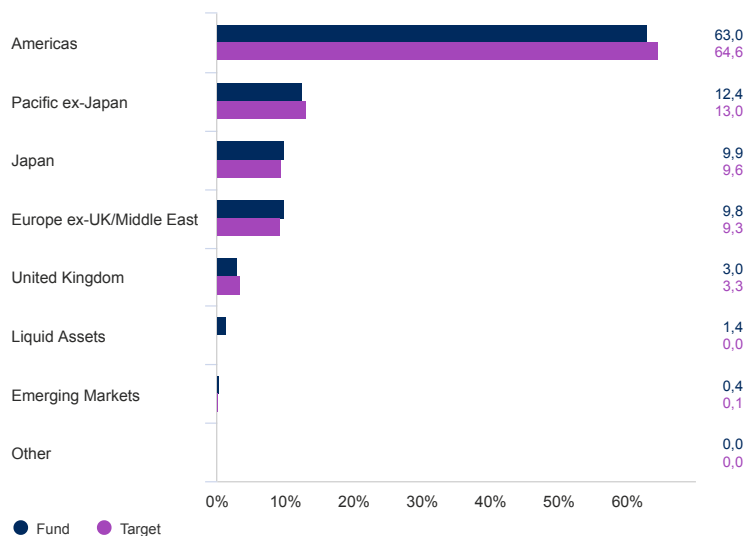


Geographical breakdown (%)

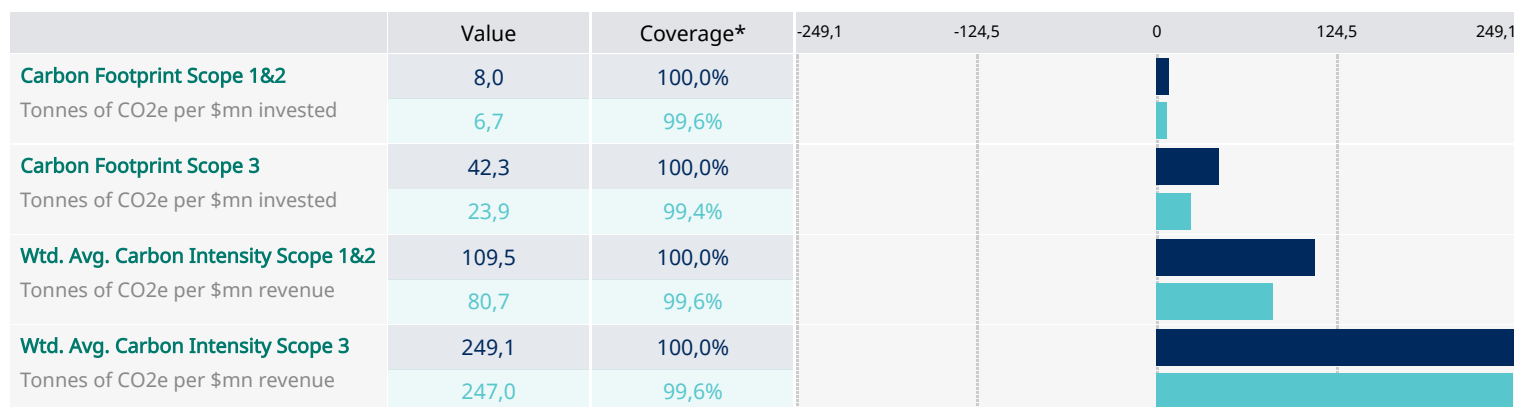

Climate dashboard

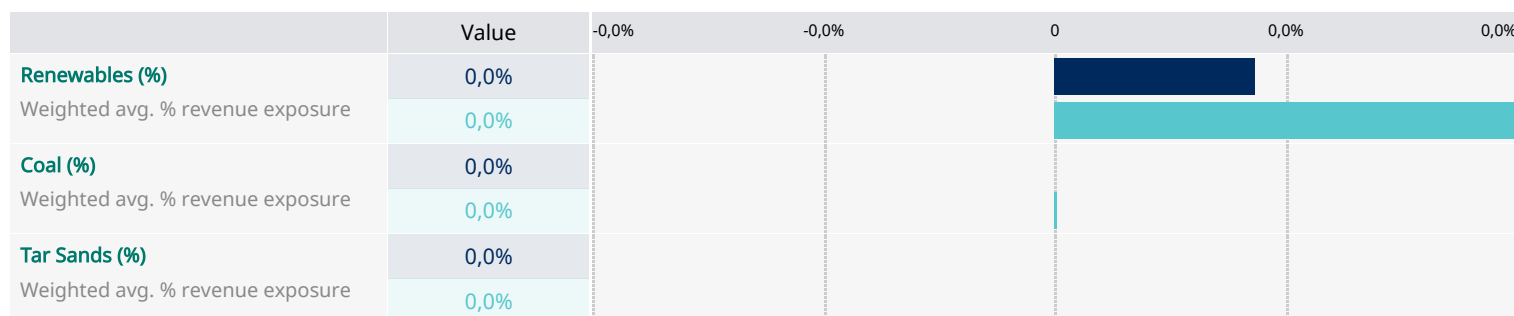
Carbon Metrics
